To consider the allocation for an augmentation to an existing grant to the California Department of Water Resources (DWR) to improve public fishing access and

enhance riparian habitat on the San Joaquin River and to improve recreational access to the California Department of Fish and Wildlife's (CDFW) San Joaquin Fish Hatchery (Hatchery). The Hatchery is located within the San Joaquin River Parkway on the south bank of the San Joaquin River about one quarter mile downstream of the Road 206 bridge in the town of Friant in Fresno County. The augmentation was considered for approval and funding by WCB on September 3, 2015. Due to a request by WCB Board members for additional information at that time, the proposal has been scheduled for further consideration at the WCB meeting scheduled for September 29, 2015.
