We are pleased to advise you that \$2,467,089 of Fiscal Year (FY) 2016 Endangered Species Act (ESA) Traditional Section 6 funds are available to your agency pursuant to our Cooperative Agreement. The Cooperative Agreement has been renewed for the current year. Thank you for the information your staff provided for the renewal.

Using both the California Department of Fish and Wildlife (CDFW) and U.S. Fish and Wildlife Service (Service) project ranking information, our Service Field Office Section 6 representatives worked closely with their CDFW counterparts to collectively recommend their highest priority projects given the known funding allocation. We hope that you are as pleased with this collaborative approach as we are.

The following is a list of the projects approved for FY 2016 CDFW Traditional Section 6 grants:

The remaining funds of \$18,601 will be applied to CDFW's 2017 allocation of Traditional Section 6 funds. Please prepare an Application for Federal Assistance (Standard Form (SF) 424) for each individual grant. We may contact your staff to help with the required environmental review and compliance associated with these projects. Completion of the grant and compliance documentation will allow the Wildlife and Sport Fish Restoration (WSFR) Program to obligate funds to your agency for costs related to these projects.
