#### Purpose

The purpose of this memorandum is to inform California Department of Fish and Wildlife (CDFW) employees that the State Controller's Office (SCO) will no longer withhold specific deductions from employee pay warrants.

### Payroll Deduction Cancellations

Effective with the June 2019 pay period, SCO will no longer withhold the deductions codes listed below from employee pay warrants. This action is being taken per California Government Code Section 1153(f), which provides for the cancellation of deductions that are not administratively feasible to maintain. Deductions organizations are aware of the payroll deduction cancellations. For deductions listed below, SCO mailed notifications to affected employees allowing sufficient time for employees to pay directly to the organization to continue membership/coverage.
