I understand that falsely applying for a replacement tag(s), and/or failure to return the original tag(s) after completion of this form, is a violation of the law, punishable by a fine of up to \$1,000 and/or imprisonment in the county jail for up to six months, and loss of deer, bear hunting privileges for up to two years. (Fish and Game Code Sections 1053.1, 1054, 4340, 4754, 12000 and 12002).
