

The California Natural Diversity Database (CNDDB) provides location and status information for California's most imperiled species. The Spotted Owl Observations Database provides information on detections and activity centers for Northern Spotted Owls and California Spotted Owls.

A subscription to the CNDDB includes:

- Access to CNDDB text information through RareFind, our online query interface.
- Access to CNDDB and Spotted Owl map data through BIOS, our online map viewer.
- Ability to generate CNDDB and Spotted Owl reports and maps.
- Ability to download CNDDB and Spotted Owl data for use within third-party GIS applications.

Subscribers and organizations that obtain access to the data may only use the data as necessary internally for the intended use but cannot make copies or distribute the data outside of their organization.
