Oil Spill Contingency Plan Preparers

Purpose

The objective of contingency planning is to ensure timely and effective response to oil spills by providing essential information and resources. The following is a compilation of companies that currently specialize in developing spill plans for vessels and facilities, and subsequently submit them to OSPR on behalf of the plan holder. These companies have the potential to assist you in the creation and submission of an oil spill contingency plan. Please note that this list is not exhaustive, and OSPR does not endorse or recommend any specific company. Some of these companies also offer additional services that may be necessary to fulfill regulatory requirements, such as spill management or qualified individual services. If you require contingency planning services, it is advised to contact these companies directly.
