**Second 15 Day Notice of California Notice Register 2015, No. 4-Z-2015-0113-07**

**Re: Dreissenid Mussels**

September 17, 2015

This letter is to provide you with a second 15 day continuation notice of proposed regulatory action relative to amendments to the Initial Statement of Reasons for the Department of Fish and Wildlife's proposed Dreissenid Mussel regulations, which were published in the California Regulatory Notice Register on January 23, 2015, Register 2015, No. 4-Z: OAL Notice File No. Z-2015-0113-07 and revised with a 15 day continuation notice on May 11, 2015.

The proposed additional changes for public notice are as follows:

1. Expand the discussion of the necessity of the proposed regulatory provisions as requested by the Office of Administrative Law pursuant to Government Code Section 11349(a), and
2. Add the revised Economic and Fiscal Impact Statement, STD 399, as approved by the Department of Finance to the rulemaking file pursuant to Government Code Section 11346.8(d).

Please note that the proposed regulatory language for sections 672, 672.1, 672.2, Title 14, CCR, and DFW Forms 1014, 1015, and 1016 have not changed from the original notice as amended by the May 11, 2015 continuation notice.


