


**FIGURE 4.5-1**

**Regional Map** 






**FIGURE 4.5-2** 

Newhall Ranch - RMDP/SCP EIS/EIR






**FIGURE 4.5-8**

**RMDP/SCP - Landscape Features** 




FIGURE 4.5-10




FIGURE 4.5-11-A1

**RMDP/SCP - Vegetation Communities and Land Covers** 




FIGURE 4.5-11-A2





FIGURE 4.5-11-B1


FIGURE 4.5-11-B2




FIGURE 4.5-11-C2










FIGURE 4.5-16






FIGURE 4.5-19

**Open Area - Special-Status Species Occurrences** 



**Middle Canyon Spring - Vicinity Map** 






FIGURE 4.5-24




FIGURE 4.5-25





FIGURE 4.5-33-A1





FIGURE 4.5-33-B1





FIGURE 4.5-33-C1




