ATTACHMENT TO NOTICE OF EXEMPTION Adoption of Dreisennid Mussels Prevention and Control Regulations

The California Department of Fish and Wildlife (CDFW), by and through its Director, has taken final action under the Fish and Game Code and the Administrative Procedure Act (APA) with respect to the project mentioned above. On July 9, 2015, CDFW adopted the proposed Dreisennid mussels prevention and control regulations. (Title 14, sections 672, 672.1, and 672.2,, California Code of Regulations (CCR).) On January 23, 2015, CDFW initiated a regular rulemaking to adopt of the prevention and control regulations of dreissenid mussels (quagga and zebra mussels) in California pursuant to Fish and Game Code sections 2301 and 2302. (California Regulatory Notice Register 2015, No. 4-Z, pp. 148-151.) A public meeting/hearing was held on March 12, 2015. On May 11, 2015, CDFW provided a continuation notice of modifications to the draft regulations as initially made available, and related Forms. CDFW prepared and submitted its Final Statement of Reasons and associated documentation to the Office of Administrative Law on July 15, 2015.

Categorical Exemptions to Protect Natural Resources and the Environment

In the adoption of regulations for the prevention and control of dreissenid mussels (quagga and zebra mussels) in California pursuant to Fish and Game Code sections 2301 and 2302, CDFW concluded for purposes of CEQA that its action falls within the Class 7 and 8 categorical exemptions.

The proposed regulations meet the criteria for several categorical exemptions. First, they fall into both California Code of Regulations, Title 14, Section 15307, Actions by Regulatory Agencies for Protection of Natural Resources, and California Code of Regulations, Title 14, Section 15308, Actions by Regulatory Agencies for Protection of the Environment. In enacting Fish and Game Code sections 2301 and 2302, the Legislature highlighted the impacts of dreissenid mussels to the ecological health, food webs, and the utility infrastructure and natural resources of the State. The proposed regulations provide CDFW with procedures to verify that the activities required per 2301 and 2302 are being implemented throughout the state, procedures for CDFW and its agents to quarantine conveyances that may be carrying mussels, and a process for enforcing the Code sections. Therefore, the proposed regulations would enhance CDFW's abilities to oversee maintenance and protection of uninfested waterways, and to limit the spread of dreissenid mussels from infested waters.

The proposed regulations also are exempt under the general rule that CEQA applies only to projects that have the potential for causing a significant effect on the

environment. (California Code of Regulations, Title 14 § 15061(b)(3)). The proposed regulations would implement requirements already laid out in Fish and Game Code (FGC) Sections 2301 and 2302 and do not require entities subject to these sections to implement new projects and/or programs. The proposed regulations establish administrative processes and oversight for prevention, control, education and enforcement activities that already occur throughout the state, but do not change those underlying activities in a manner that creates potentially significant impacts to the environment. In addition, through improved administration, CDFW will further reduce the potential adverse impacts to biological resources caused by the spread of dreissenid mussels.
