



## 2019 COMMERCIAL FISHING ITEMS AND FEES

Fee includes 5% License Agent Handling Fee and 3% Nonrefundable Application Fee

A commercial fishing license is required for anyone 16 years of age or older who uses, operates, or assists in using or operating any boat, aircraft, net, trap, line, or other appliance to take fish for commercial purposes, or who contributes materially to the activities on board a commercial fishing vessel.
