Background



Settlement funds from the 2007 *Cosco Busan* oil spill continue to be spent on restoration projects. To date, nearly \$20 million of the \$30.5 million settlement has been allocated to over 50 projects, designed to enhance and restore beaches and habitat around the Bay Area and beyond.

Eden Landing Salt Ponds Management



Marbled Murrelet Restoration

Working with Humboldt Redwoods and Grizzly Creek State Parks, new animal-proof food lockers, garbage containers, and French drains (like these at Albee Creek Campground) are being installed at all campgrounds. This is to reduce the number of jays and ravens, which eat murrelet eggs and chicks. The work will take three years to complete. Restoration work in the Santa Cruz Mountains continues (see previous newsletters). Improvements to levees and water control structures are continuing at Eden Landing Wildlife Area in the South Bay. This enables John Krause (left) to manage vast acres of ponds for Snowy Plovers in the summer and diving ducks in the winter. This tide gate, with a rotten piling visible on the far left, will be replaced with a concrete structure. Complementing the project, other ponds are being converted to wetland habitat and public access trails are being extended.



Surf Scoter Restoration



After wintering in San Francisco Bay, surf scoters head north to the breeding grounds, stopping in the Puget Sound area on the way. Here, they are subject to mortality from derelict fishing nets. A project to search for and remove these nets in the Salish Sea began last summer. Four nets were removed, including two snagged on masts of sunken vessels (see photo at left); bird bones were found in and underneath the nets. Forty-two recreational use projects are under way around the Bay Area. Here are some recent pictorial highlights:
