## NEW APPLICANTS MUST INCLUDE YOUR GO ID NUMBER OR A COPY OF YOUR IDENTIFICATION

Please allow 15 business days for processing the application. Incomplete applications will be returned and could delay the issuance of your license. Contact the License and Revenue Branch at (916) 928-5846 or SPU@wildlife.ca.gov if you need additional information regarding domesticated game breeder's licenses.

1. It is mandatory to submit all items unless specified as voluntary.
2. Sign and date the application.
3. If you are renewing your license, you must complete a 2023 Domesticated Game Breeder's Report Form by January 31, 2024.

NOTE: You must submit a completed 2023 Domesticated Game Breeder's Report Form for the 2023 license year by January 31, 2024, even if you are no longer possessing stock and not renewing your license.
4. Mail this application, a completed Domesticated Game Breeder's Report Form (renewal applicants), and a cashier's check, money order, personal or business check* or credit card** authorization form with the appropriate fee to the Department of Fish and Wildlife, License and Revenue Branch, P.O. Box 944209, Sacramento, CA 94244-2090. DO NOT SEND CASH.***

NOTE: To import game mammals for breeding purposes, a separate permit may be required from the Department of Fish and Wildlife, License and Revenue Branch, please contact (916) 928-5846 to inquire. Federal permits are required if you wish to acquire, purchase, transfer, sell or otherwise dispose of migratory game birds. ## INDIVIDUAL AND BUSINESS IDENTIFICATION REQUIREMENTS

Section 700.4(c), Title 14, of the California Code of Regulations (CCR) states any applicant applying for any license, tag, permit, reservation or other entitlement issued via the Automated License Data System (ALDS) shall provide valid identification. Acceptable forms of individual identification include:

- US Birth Certificate
- US Certificate or Report of Birth Abroad
- Tribal Identification Card, as defined by each sovereign tribal nation
- US Passport
- A foreign government-issued photo identification
- Certificate of Naturalization or Citizenship
- Birth Certificate or passport issued from a US Territory

Any applicant less than 18 years of age applying for any license, tag, permit, reservation or other entitlement issued via the ALDS shall provide valid identification. Acceptable forms of identification include any form of identification described above; or a parent or legal guardian's identification as described above.

All business applicants must provide documentation identifying the business' structure type. Acceptable forms of business identification include:

- Articles of Incorporation
- Articles of Organization
- Statement of Partnership Authority
- Certificate of limited Partnership

If a business' identification names individual(s), each individual must provide a valid individual identification as described above and provide their date of birth, sex, hair and eye color, height and weight.
