This Amendment to the Planning Agreement regarding the Orange County Transportation Authority (“OCTA”) Natural Community Conservation Plan and Habitat Conservation Plan (NCCP/HCP), which is a joint document, is made and entered into by and between the OCTA, the California Department of Transportation (“Caltrans”), the California Department of Fish and Wildlife (“DFW”), and the United States Fish and Wildlife Service (“USFWS”). These entities are referred to collectively as “Parties” and each individually as a “Party.” This Amendment to the Planning Agreement is made with reference to the following Recitals.

Recitals

A. The Parties have entered into a Planning Agreement regarding the OCTA Multiple Species Conservation Program Plans (“Planning Agreement”).

B. The terms used in this Amendment will have the meanings set forth in Section 1 of the Planning Agreement.

C. The Effective Date of the Planning Agreement is January 21, 2010. Pursuant to Section 8.5 of the Planning Agreement, the Planning Agreement will automatically terminate four (4) years from the Effective Date unless it is extended by an amendment or terminated pursuant to Section 8.7 of the Planning Agreement.

D. The Parties now desire by this Amendment to extend the Duration of the Planning Agreement for an additional twelve (12) months, to January 21, 2017.

Terms and Conditions

1. The Duration of the Planning Agreement is hereby extended for an additional twelve (12) months beyond the current termination date. This additional twelve-month term shall be referred to as the “Third Extension Period.”

2. All other terms and conditions of the Planning Agreement shall remain in full force and effect during the Third Extension Period.

3. This Amendment will take effect on the date that it is executed by the OCTA, Caltrans, DFW, and USFWS.

4. Any modifications to this Amendment must be in writing and signed by all Parties.






