Subject: Results of Jun 21-Aug 5 Pilot Sturgeon Angler Phone Survey

This report describes data, methods, and algorithms used in a phone survey (survey) that questioned "avid" anglers who had not returned their 2015 Sturgeon Fishing Report Card (Card).

The purpose of the survey was to learn why avid anglers did not return their Cards, to estimate the catch documented by avid anglers on Cards that had not been returned to us, and to learn about emphasis for additional outreach regarding the Department's sturgeon population study and about the regulation requiring timely submission of Cards or on-line reporting of Card data.

Prior to conducting the survey, Jason DuBois created a list of 1,000 randomly-selected avid anglers who had not returned their 2015 Card. For the purposes of the survey, we characterized avid anglers as those who purchased a Card in 2014 and 2015.

I made all the calls. When a call went to voicemail, I left a message describing the survey and I left a return phone number. If the call was answered, I told the listener that the call is a survey about sturgeon fishing and asked to speak with the avid angler. If I spoke with the avid angler, I asked the avid angler to participate in the survey. If the avid angler agreed to participate in the survey, I asked the questions on the Report Card Survey Form (Appendix A). At the end of a call, I recorded the time, the avid angler's name, the date, and notes.

I made calls to 1,000 avid anglers and spoke with 248 avid anglers. Call duration ranged roughly 2-3 minutes when answered via voicemail and roughly 3-4 minutes when I spoke with the angler.

Of the 248 avid anglers I spoke with, 4 said they returned their Card by hand, 31 said they returned their Card by mail, 27 said they provided their Card data on-line, 13 said they did not know to return their Card, 13 said they forgot to return their Card, and 80 said they decided not to return their Card.

Of the 248 avid anglers I spoke with, 132 said they fished for sturgeon. Those 132 avid anglers said they kept 19 White Sturgeon, released 152 White Sturgeon, and released 3 Green Sturgeon.

Of the 237 avid anglers who answered the question about the regulation requiring timely submission of Cards or on-line reporting of Card data, 93 said they knew about the regulation.

Of the 239 avid anglers who answered the question about the Department's sturgeon population study, 135 said they knew about the study.
