## **Results for the Disabled Employee Survey**

• Tina Cole provided us with information regarding the Survey Rate and Percentages. We will receive a copy of the results at the next DAC meeting or by email prior to that date. Information gathered from the 2015 survey report, was reported that our department has109 males or (3.7%), 110 females or (3.8%) in short, it represented at least 219, or 7/5% of CDFW. These numbers reflect there are at least 483.89 persons with disabilities in CDFW's workforce. We are hopeful that in the future to come we can establish more information to gear towards our website so that we can increase the pull. Also we understand some employees may possibly be reluctant on giving out this type of information.
