

SECOND AMENDMENT TO

REGARDING THE

**YOLO COUNTY NATURAL COMMUNITY CONSERVATION PLAN AND HABITAT
CONSERVATION PLAN**

This Second Amendment to the Planning Agreement regarding the Yolo County Natural Community Conservation Plan and Habitat Conservation Plan ("Planning Agreement") is made and entered into by and between the Yolo County Habitat Conservation Plan/Natural Community Conservation Plan Joint Powers Agency, referred to and known generally as the Yolo Habitat Conservancy ("Conservancy"), the California Department of Fish and Wildlife ("DFW"), and the United States Fish and Wildlife Service ("USFWS"). These entities are referred to collectively as "Parties" and each individually as a "Party." This Agreement is made with reference to the following Recitals.

Recitals

A. On November 9, 2004, the Parties entered into a Planning Agreement regarding the Yolo County Natural Community Conservation Plan and Habitat Conservation Plan.

B. The Effective Date of the Planning Agreement is February 8, 2005. Pursuant to Section 7.5 of the Planning Agreement, the Planning Agreement automatically terminates five (5) years from the Effective Date unless it is extended by an amendment or terminated pursuant to Section 7.7 of the Planning Agreement.

C. The Parties entered into a First Amendment to the Planning Agreement on June 15, 2009, which extended its term for three years to February 8, 2013.

D. The Parties now desire by this Second Amendment to the Planning Agreement to formally extend the duration of the Planning Agreement to April 30, 2019.

Terms and Conditions

1. The Duration of the Planning Agreement, as extended by the First Amendment, is hereby extended to April 30, 2019. This additional term shall be referred to as the "Second Extension Period."

2. All other terms and conditions of the Planning Agreement shall remain in full force and effect during the Second Extension Period.

3. This Second Amendment is effective on the date of its execution by the DFW and Conservancy.

4. Any modifications to this Second Amendment must be in writing and signed by all Parties.
