<i>Resubmittal Review</i>	<i>Up to \$22,000.00</i>	<i>Up to \$22,714.75</i>	<i>If the submittal is not initially accepted by CDFW, it can be resubmitted after revision and CDFW may impose a fee up to \$22,714.75. Minor changes or changes mutually agreed upon as attributable to early program implementation may not be subject to any resubmittal fees.</i>
<i>Unsolicited Changes</i>	<i>Up to \$11,000</i>	<i>Up to \$11,357.50</i>	<i>One-time fee of up to \$11,357.50 for unsolicited changes proposed by the applicant during the review period to cover the reasonable cost of CDFW's services in reviewing a change that it determines will require additional CDFW staff time.</i>
Updates and Amendments			
Data Update	--	--	Data Updates are free and CDFW encourages them by waiving a fee. However, CDFW may add a fee for Data Updates in the future, if needed. A Data Update is generally the submission of GIS data or minor changes to numbers or text in the document that require less than 2 hours of CDFW staff time.
Simple Amendment	\$7,300	\$7,537.25	A Simple Amendment would include small or minor changes to the document that are more than a Data Update, but that do not result in substantial changes, as determined by CDFW.
Complex Amendment	\$22,000	\$22,714.75	If the initial Simple Amendment fee was already paid and was subsequently deemed to be complex by CDFW, the additional fee would be \$15,177.50. A Complex Amendment would result in a substantial change to the document, such as the addition of an ecoregion, as determined by CDFW.
<i>Unsolicited Changes</i>	<i>\$11,000</i>	<i>\$11,357.50</i>	<i>This is a one-time fee for unsolicited changes proposed by the applicant (that have not been solicited by CDFW) during the amendment review period to cover the reasonable cost of CDFW's services in reviewing a change that it determines will require additional CDFW staff time.</i>

¹ Fees will be adjusted annually using the Implicit Price Deflator (IPD) for State and Local Government Purchases of Goods and Services, as published by the United States Department of Commerce. The rate of change for the annual fee adjustment is determined by comparing the March 31 quarter end IPD index of the current year to the March 31 quarter end IPD index of the prior year. Each current fee is multiplied by the relative amount of change in the IPD index. The product is added to the fee for the current year and then rounded to the nearest \$0.25 increment. The resulting amounts are the adjusted fees for the new calendar year, beginning January 1.

² Fees may be adjusted based on an evaluation of the actual time required by CDFW staff to review and approve RCIS Program documents.

Minor changes or changes mutually agreed upon as attributable to early program implementation may not be subject to any resubmittal fees.</i>
<i>Unsolicited Changes</i>	<i>Up to \$14,250.00</i>	<i>Up to \$14,713.00</i>	<i>One-time fee of up to \$14,713.00 for unsolicited changes proposed by the applicant during the review period to cover the reasonable cost of CDFW's services in reviewing a change that it determines will require additional CDFW staff time.</i>
Updates and Amendments			
Data Update	--	--	Data Updates are free and CDFW encourages them by waiving a fee. However, CDFW may add a fee for Data Updates in the future, if needed. A Data Update is generally the submission of GIS data or minor changes to numbers or text in the document that require less than 2 hours of CDFW staff time.
Simple Amendment	\$9,500.00	\$9,808.75	A Simple Amendment would include small or minor changes to the document that are more than a Data Update, but that do not result in substantial changes, as determined by CDFW.
Complex Amendment	\$28,500.00	\$29,426.00	If the initial Simple Amendment fee was already paid and was subsequently deemed to be complex by CDFW, the additional fee would be \$19,617.25. A Complex Amendment would result in a substantial change to the document, such as changes to the geographic area, focal species, or other conservation elements, as determined by CDFW.
<i>Unsolicited Changes</i>	<i>\$14,250.00</i>	<i>\$14,713.00</i>	<i>This is a one-time fee for unsolicited changes proposed by the applicant (that have not been solicited by CDFW) during the amendment review period to cover the reasonable cost of CDFW's services in reviewing a change that it determines will require additional CDFW staff time.</i>
