## ADDITIONAL INFORMATION

Hunters must have a valid/current 2017-2018 California hunting license and Upland Game Bird validation. Junior hunters do not need an Upland Game Bird validation. A junior hunter must be accompanied by a non-shooting adult 18 years of age or older. Nonlead ammunition is required on all California Department of Fish and Wildlife Lands. All shooters and non-shooters must wear shooting/safety glasses, blaze orange, and initial and sign a waiver (enclosed), for the hunt. Your guest(s) must be present with you when you check in.

The Department may make blaze orange vests and Shooting Safety Glasses available on a loan basis. However, failure of the Department to have these items available for loan does not relieve the Hunt Participant from using these items.

A shooting range and clay target thrower will be provided to allow beginning hunters shooting practice before the hunt. Please bring extra **non-lead ammunition** and take advantage of this opportunity.

Please come prepared and wear appropriate gear for the hunt; we strongly recommend you bring water, a hat, sturdy shoes/boots, sweater/jacket, and a cooler with ice for your birds. For safety, Apprentice hunters must have a properly fitting shotgun. Please note if you are not prepared for the hunt or your gear is deemed unsafe you may be asked to withdraw from the hunt.

This hunt was made possible by the purchases of the Upland Game Bird Stamp. Practice good sportsmanship, be a safe hunter and most of all enjoy your hunt. If you require any special accommodations, **cannot attend this hunt**, or have any questions please contact the Department of Fish and Wildlife at (530) 294-5824.

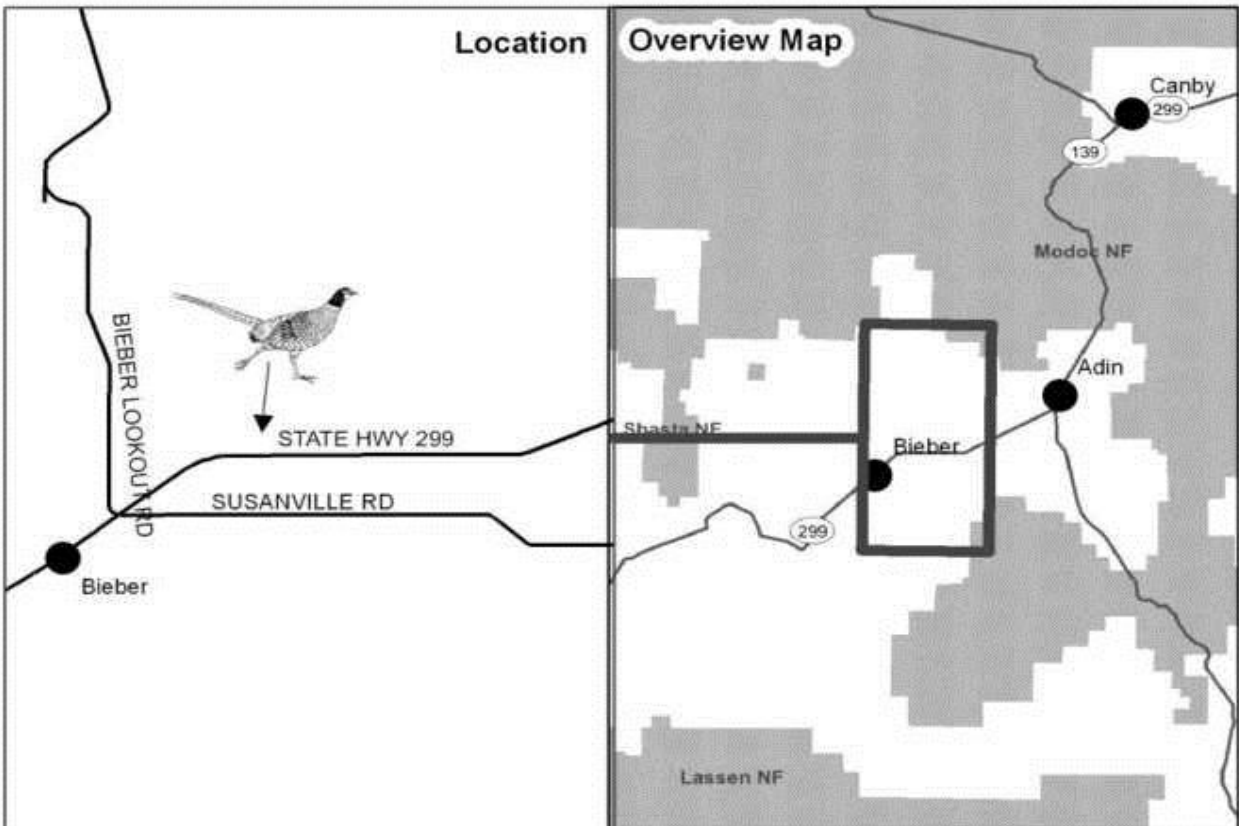
## Ash Creek Wildlife Area Apprentice Pheasant Hunt for Women

A **Mandatory** hunter safety meeting will be given to all participants prior to the start of the hunt.

All Junior hunters must be accompanied by an adult, at least 18 years of age. An adult may accompany up to two junior hunters

Additional Guidelines for Women Apprentice Hunts are;

- **Only Non-Lead shot will be allowed.** All participants must bring their own ammunition and shotgun.
- **Blaze Orange** (hunter orange hat and or vest) is **Mandatory for all participants** while in the field. The Department will make Blaze orange vest available on a loan basis.
- **Shooting Safety Glasses** are **Mandatory** for all participants and must conform to ANSI rating of Z87.1 or above. Loaner safety glasses will be available. All Adults are encouraged to wear shooting safety glasses.



Ash Creek Wildlife Area headquarters is **3** miles east of Bieber on **State HWY 299**.

## **The Ten Commandments of Firearms Safety:**

1. Watch that muzzle! Keep it pointed in a safe direction at all times.
2. Treat every firearm with the respect due a loaded gun.
3. Be sure of your target and what is in front of it and beyond it.
4. Keep your finger outside the trigger guard until ready to shoot .
5. Check your barrel and ammunition.
6. Unload firearms when not in use.
7. Point your firearm only at something you intend to shoot.
8. Don't run, jump, or climb with a loaded firearm.
9. Store firearms and ammunition separately and safely.
10. Don't drink alcohol, use drugs or take medications that might impair your abilities and good judgment before or while handling firearms or archery equipment.

READ, INITIAL AND SIGN BEFORE HUNT DAY

Waiver of Potential Claims and Release of Liability

I, \_\_\_\_\_, as a condition of my being able to participate in hunting activities on State property acknowledge and represent to the State of California each of the following:

1. Hunting is an inherently dangerous activity that can result in serious injuries or death caused by myself or other people who are present, participating in or watching such activities. \_\_\_\_\_.

Hunting also includes an inherent risk of serious injury or death caused by conditions of the land, including both defects in or improvements thereto, or natural conditions including animals (whether those being hunted or not) on the property. I acknowledge that in allowing me to participate in hunting activities on State property, the State owes me no duty to supervise the activity or the persons participating in or watching the activity. I further acknowledge that by providing rules, signs, guides, chaperones or other volunteers to assist in hunting activities, neither the State, its agents, employees and/or volunteers owe me any duty whatsoever to supervise or control the actions of myself or other persons participating in, watching the activity or on the property. \_\_\_\_\_.

Waiver And Release Of Claims: I hereby expressly waive any right that I might have to sue the State, its agents, employees and/or volunteers for any physical or emotional injuries, illnesses, death or other damages that I might suffer as a result of participating in hunting activities on State property. \_\_\_\_\_.

Waiver And Release Of Claims Based On Negligence: In addition to the inherent dangers involved in hunting on State property described above, I further acknowledge that serious injuries or death may be caused by the negligent acts of State employees, its agents, volunteers or other persons which increase the risk of injury beyond those normally anticipated while hunting. I hereby expressly agree to assume the risk that I may be seriously injured or killed through the negligent acts of others. I agree to waive any right I may have to sue the State, its agents, employees and/or volunteers for injuries or death that I may suffer arising out of participating in hunting or related activities including physical or emotional injuries, illnesses or death caused by the negligent acts of the State, its agents, employees, volunteers or other persons. \_\_\_\_\_.

### Waiver of Minor's Potential Claims and Release of Liability

I further acknowledge that by providing rules, signs, guides, chaperones or other volunteers to assist in hunting activities, neither the State, its agents, employees and/or volunteers owe the Child any duty to supervise or control the actions of the Child or other persons participating in, watching the activity or on the property. \_\_\_\_\_.

Waiver And Release Of Claims: I hereby expressly waive any right that the Child might have to sue the State, its agents, employees and/or volunteers for any physical or emotional injuries, illnesses, death or other damages that the Child might suffer as a result of participating in hunting activities on State property. \_\_\_\_\_.

Waiver And Release Of Claims Based On Negligence: In addition to the inherent dangers involved in hunting on State property described above, I further acknowledge that serious injuries or death may be caused by the negligent acts of State employees, its agents, volunteers or other persons which increase the risk of injury beyond those normally anticipated while hunting. I hereby expressly agree that the Child assumes the risk that the Child may be seriously injured or killed through the negligent acts of others. I agree to waive any right the Child may have to sue the State, its agents, employees and/or volunteers for injuries or death that the Child may suffer arising out of participating in hunting or related activities including physical or emotional injuries, illnesses or death caused by the negligent acts of the State, its agents, employees, volunteers or other persons. \_\_\_\_\_.
