### Development Plan for the Lease of Kelp Beds 204 and 207 by The Abalone Farm, Inc.

The Abalone Farm, Inc. has leased and harvested kelp from Beds 204 and 207 for 30 years now. Our present leases are up for renewal next year, and The Abalone Farm, Inc. would like to exercise it's option for another 5 year lease agreement for both of these beds with the Department of Fish and Wildlife. The Abalone Farm, Inc. is in the business of growing farm-raised abalone and our business is completely dependent upon the availability and sustainable harvest of kelp, which we utilize as abalone feed. We feel that it is imperative to the long-term survival of our business that we have a secure source of feed for our abalone. I believe that our 30 year history of harvesting kelp and maintaining our kelp leases speaks well of our ability to fulfill our development plan.

The Abalone Farm, Inc. owns and operates all of the equipment required for harvesting and transporting kelp to our production facility. The principal harvest vessel is a modified 56 ton LCM, the "Ocean Rose". The Ocean Rose uses mechanized harvest equipment designed by AFI and has a maximum cargo capacity of 20 tons.

The harvested kelp is transported using the company's own trucks and cranes. AFI currently owns a Volvo crane truck with a maximum capacity of 12 tons.

During the past 5 years (2012-2016), our average annual kelp harvest has been 1713 tons from Bed 207, and 270 tons from Bed 204. We anticipate that our harvest will remain at comparable levels for the next five years.
