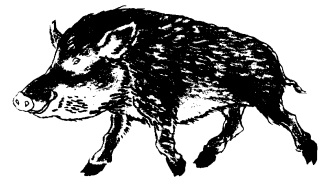




## Joice Island Wild Pig Hunt Permit Permit Valid only for April 21-22, 2018



Congratulations! You have been drawn for the Joice Island Pig Hunt  
**Please call if you cannot attend!** There are many others waiting to take your spot!

**Location:** The wild pig hunt will be held on the Joice Island Unit of the Grizzly Island Wildlife Area in Solano County. From I-80, take Highway 12 East exit (towards Rio Vista). After Approx. 5 miles, turn South onto Grizzly Island Road (Jack in the Box on corner). Proceed 5 miles and turn right at the Joice Island gate (if you get to a boat ramp area you have gone too far).

**Sign In:** You must sign in at the self-registration booth before crossing over the Joice Island Bridge. Area Use Permits will be in the registration booth. One permit per hunter will be valid for both hunt days. Your non-shooting guest can be accounted for on your area permit under number in party. You must have in your possession: this Pig Hunt Permit, an Area Use Permit, valid California hunting license, and wild pig tag(s) during this hunt. The combination to the gate for your hunt weekend is **"HAMS" 4267**. The gate must remain closed and locked at all times. Shoot hours are from one-half hour before sunrise to one-half hour past sunset.

**Sign Out:** All hunters must sign out at the self-registration booth at the end of their hunting weekend. You must leave your *completed* Area Use Permit, and if you take a pig, leave the mail-in portion of your pig tag(s), in the box provided at the registration booth. Please reuse your Area Use Permit for the second day of your hunt. Just remember to leave everything in the booth when you leave the Wildlife Area.

- **ONLY SHOTGUNS USING APPROVED NON LEAD SLUGS AND ARCHERY EQUIPMENT WILL BE ALLOWED FOR THIS HUNT.**
- **TWO (2) PIG LIMIT PER HUNTER.**
- This permit is valid for only **ONE licensed hunter and ONE non-shooter** for the dates specified; permits are not transferable. **NO Exceptions to this rule!**
- There is no boat or ATV access allowed for this hunt area.
- Parking is only allowed at the designated parking lots (1-4). Pigs are to be retrieved by foot, or cart. If the road becomes un-drivable due to weather conditions you will be notified by phone and posted signs. At that time you will only be allowed to park at parking lot 1-2 and walk onto the island.
- No Bicycles Allowed
- **NO HANDGUNS ALLOWED!**
- Hunt participants may stay in a self-contained vehicle at the parking area (entrance to Joice Island, before the wooden bridge) after 6 PM on Friday night before their hunt period. All vehicles must be gone by 2 hours after shoot time on Sunday night. No trailers allowed. Portable toilet provided – no other facilities are available.
- **NO OPEN FIRES ALLOWED!** Only gas stoves may be used.
- Refer to the map, and use extra caution around the areas designating the duck club houses.
- Hunt participants must remain on state property. Adjacent property is private - no trespassing allowed.
- It is unlawful to litter. Please keep this area clean by removing all trash.
- **NO SCOUTING BEFORE YOUR HUNT DATE**

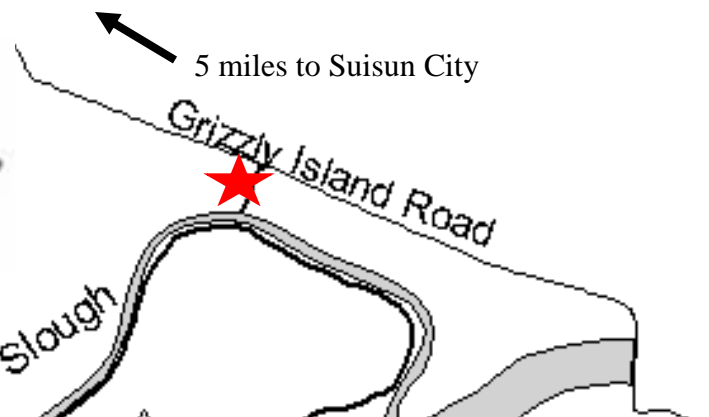

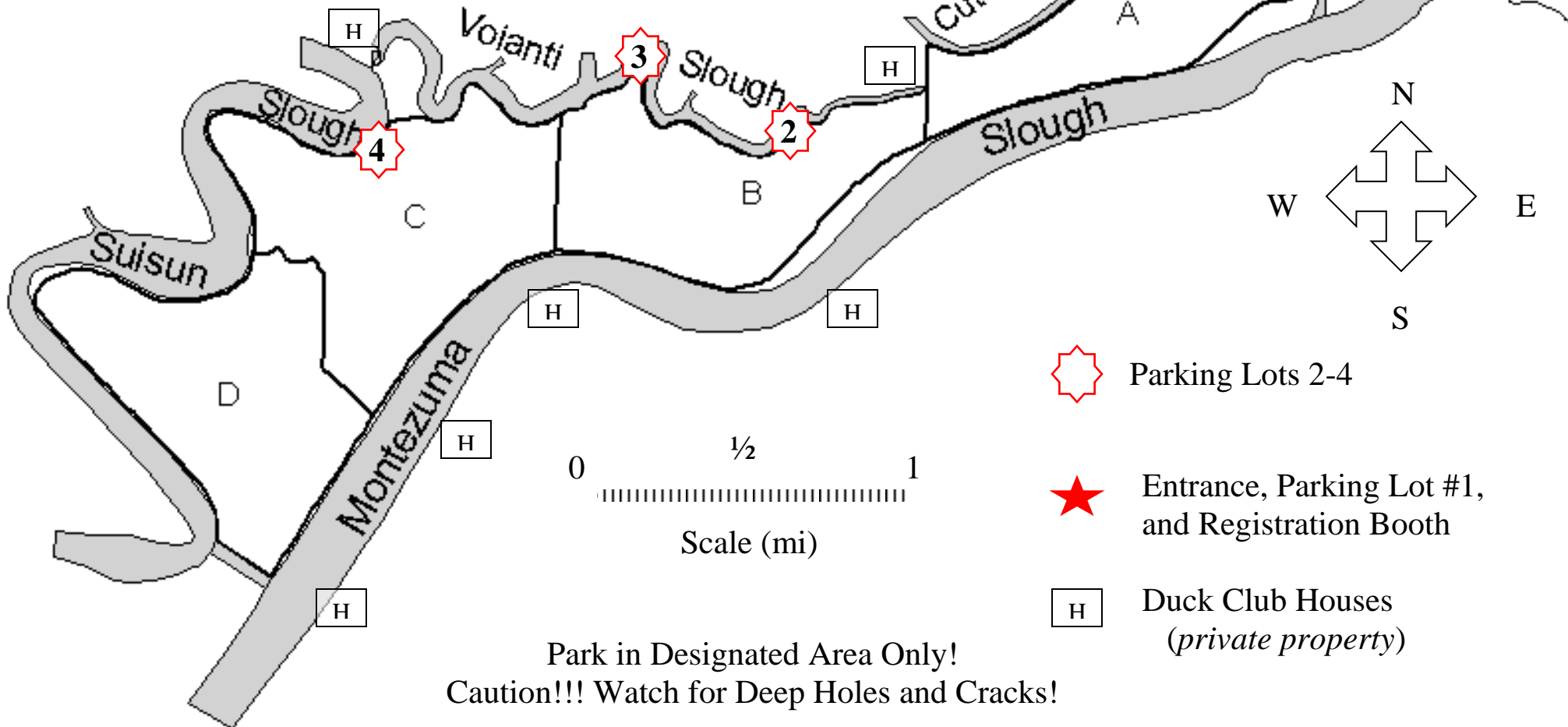
## Joice Island Unit

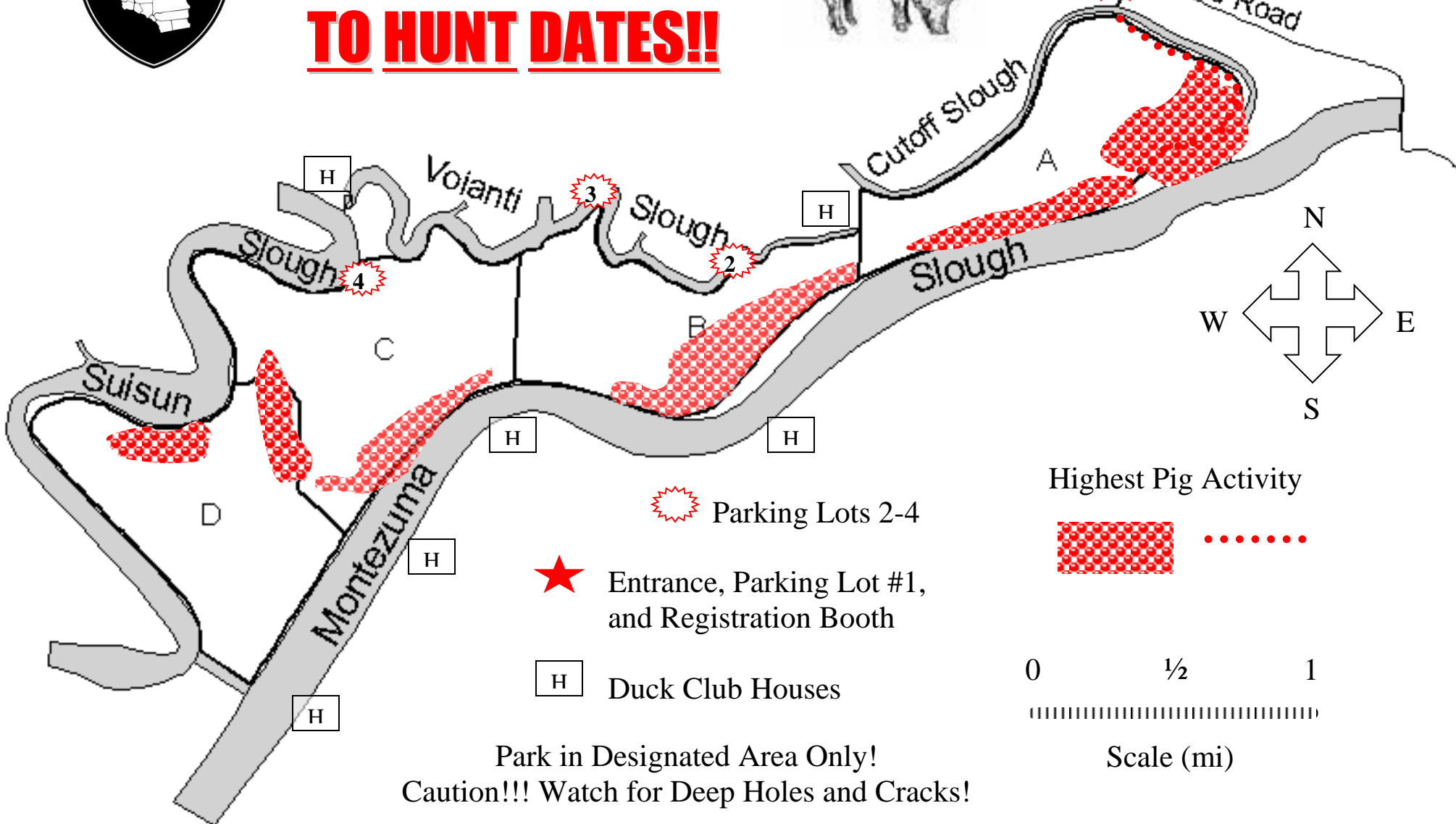
