Instructions: Student Permitholders, and Principal Investigators, or any Authorized Individual on an Entity or Individual permit shall notify the Department Law Enforcement offices and Department regional contacts at least 36 hours, but not more than 14 calendar days, prior to conducting permitted activity(ies) in the field, unless otherwise specified in the conditions of the permit. All fields on this form are required.
