Timeline of Crab Disaster Relief

- CA Final Spending Plan due to PSMFC September 7, 2018
- Grant application submitted by September 14, 2018
- Funds have an anticipated start date of January 1, 2019
 - Funds need to be spent within a 24 month period
 - Any proposed projects must be completed within the 24 months
 - Assumes NOAA accepts the grant proposal without significant changes
 - Assumes no significant opposition or litigation

Calculations for Weighting Industry Sectors

Following slides summarize how qualifying permits and licensed business in each industry sector were weighted to determine disaster relief reimbursement

Option 1 (suboption) – Dungeness crab Fishermen: Weighted by Dungeness Crab Vessel Permit Tier

- Determine qualifying permits (i.e. either at least one landing in the last three seasons prior to disaster season or at least one landing in the recent seasons of 2016-17 or 2017-18)
- Bin permit into representative trap limit tier (i.e. Tier 1 to 7)
- Calculate total number of traps these permits represent (fishing power) based on corresponding trap limit (i.e. 175 to 500 traps)
- Calculate per trap reimbursement by dividing total direct payment allotted to Dungeness crab fishermen by total number of traps
- Multiply per trap reimbursement by each of the 7 tiered trap limits to determine the per permit reimbursement weighted by tier

Revised Option – Dungeness crab Processors: Weighted by Cumulative Total of Dungeness Crab Received Pounds

- Determine qualifying licensed businesses that were licensed in 2015 and 2016 with at least one record of receiving Dungeness crab in the last three seasons prior to disaster season (i.e. 2012-13 to 2014-15)
- Calculate cumulative totals for each licensed business using all records of receiving Dungeness crab over the three seasons, remove those licenses that received less than 1,000 lbs cumulative total
- Tier licensed businesses determined by cumulative total pounds in to the following 6 tiers: ≥4million, 1.5million - 3.99million, 1million - 1.49million, 500,000 - 999,999, 100,000 - 499,999 and 1,000-99,999
- Calculate the percent each tier contributes to the summed total of cumulative pounds for all three seasons
- Use this percent to determine the tier allocation by multiplying the total direct payment allotted to Dungeness crab processors
- Divide the tier allocation by the number of licensed businesses that qualify under this tier to determine the per licensed business reimbursement

Revised Option – Dungeness crab CPFVs: Weighted by Cumulative Total of Dungeness Crab Trips

- Determine qualifying licensed CPFV's that were licensed in 2015 and 2016 and have at least 10 daily trips recorded with Dungeness crab taken during the Dungeness crab recreational seasons of 2012-13, 2013-14 and 2014-15
- Calculate cumulative total of all trips over the three seasons for each licensed CPFV
- Tier licensed CPFVs determined by cumulative trips in to the following 3 tiers : ≥100 trips, 50-99 trips and 10-49 trips
- Calculate the percent each tier contributes to the summed cumulative total of all Dungeness crab trips recorded for all three seasons
- Use this percent to determine the tier allocation by multiplying the total direct payment allotted to Dungeness crab CPFVs
- Divide the tier allocation by the number of licensed businesses that qualify under this tier to determine the per licensed CPFV reimbursement

Revised Option – Rock crab Fishermen: Weighted by Cumulative Total of Rock Crab Landed Pounds

- Determine qualifying licensed fishermen that were permitted in 2015 and 2016 with at least one record of landing rock crab in the affected blocks in the last three years prior to disaster year (i.e. 2012, 2013 & 2014)
- Calculate cumulative totals for each licensed fishermen using all records of landing rock crab over the three years, remove those licenses that received less than 1,000 lbs cumulative total
- Tier licensed fishermen determined by cumulative total pounds in to the following 6 tiers: ≥500,000, 400,000 499,999, 300,000 399,999, 100,000 299,999, 30,000 99,999 and 1,000 29,999
- Calculate the percent each tier contributes to the summed total of cumulative pounds for all three seasons
- Use this percent to determine the tier allocation by multiplying the total direct payment allotted to rock crab fishermen
- Divide the tier allocation by the number of licensed fishermen that qualify under this tier to determine the per rock crab permit reimbursement

Revised Option – Rock crab Processors: Weighted by Cumulative Total of Rock Crab Received Pounds

- Determine qualifying licensed businesses that were licensed in 2015 and 2016 with at least one record of landing rock crab in the affected blocks in the last three years prior to disaster year (i.e. 2012, 2013 & 2014)
- Calculate cumulative totals for each licensed business using all records of receiving rock crab over the three years, remove those licenses that received less than 1,000 lbs cumulative total
- Tier licensed businesses determined by cumulative total pounds in to the following 6 tiers: ≥350,000, 200,000 349,999, 150,000 199,999, 100,000 149,999, 50,000 99,999 and 1,000 49,999
- Calculate the percent of each tier contributes to the summed total of cumulative pounds for all three seasons
- Use this percent to determine the tier allocation by multiplying the total direct payment allotted to rock crab processors
- Divide the tier allocation by the number of licensed businesses that qualify under this tier to determine the per licensed business reimbursement
