**ADDITIONAL INFORMATION**

Hunters must possess a valid 2018-2019 California hunting license and upland game bird stamp. Hunters possessing a junior hunting license do not need an upland game bird stamp and must be accompanied by a non-shooting adult 18 years of age or older. All shooters and non-shooters must wear shooting safety glasses, blaze orange, and initial and sign the enclosed waiver.

Please come prepared and wear appropriate gear for the hunt; we strongly recommend you bring water, a hat, sturdy shoes/boots, sweater/jacket, mosquito repellent and a cooler with ice for your birds. For safety, Apprentice hunters must have a properly fitted shotgun. Please note if you are not prepared for the hunt or your gear is deemed unsafe you may be asked to withdraw from the hunt.

The Upland Game Bird Special Hunts Program is pleased to offer you this special hunt. Practice good sportsmanship, enjoy your hunt and most of all, be a safe hunter.

• Effective July 1, 2016, non-lead shot will be required when taking upland game birds with a shotgun, except for dove, quail, snipe, and any game birds taken on licensed game bird clubs.

• Effective July 1, 2015, NON-LEAD AMMUNITION will be required when hunting on ALL CDFW Lands.

Permits are required of all persons entering the field. All hunters, escorts, and dog handlers are required to obtain a free use permit at the check station before entering the hunt area.

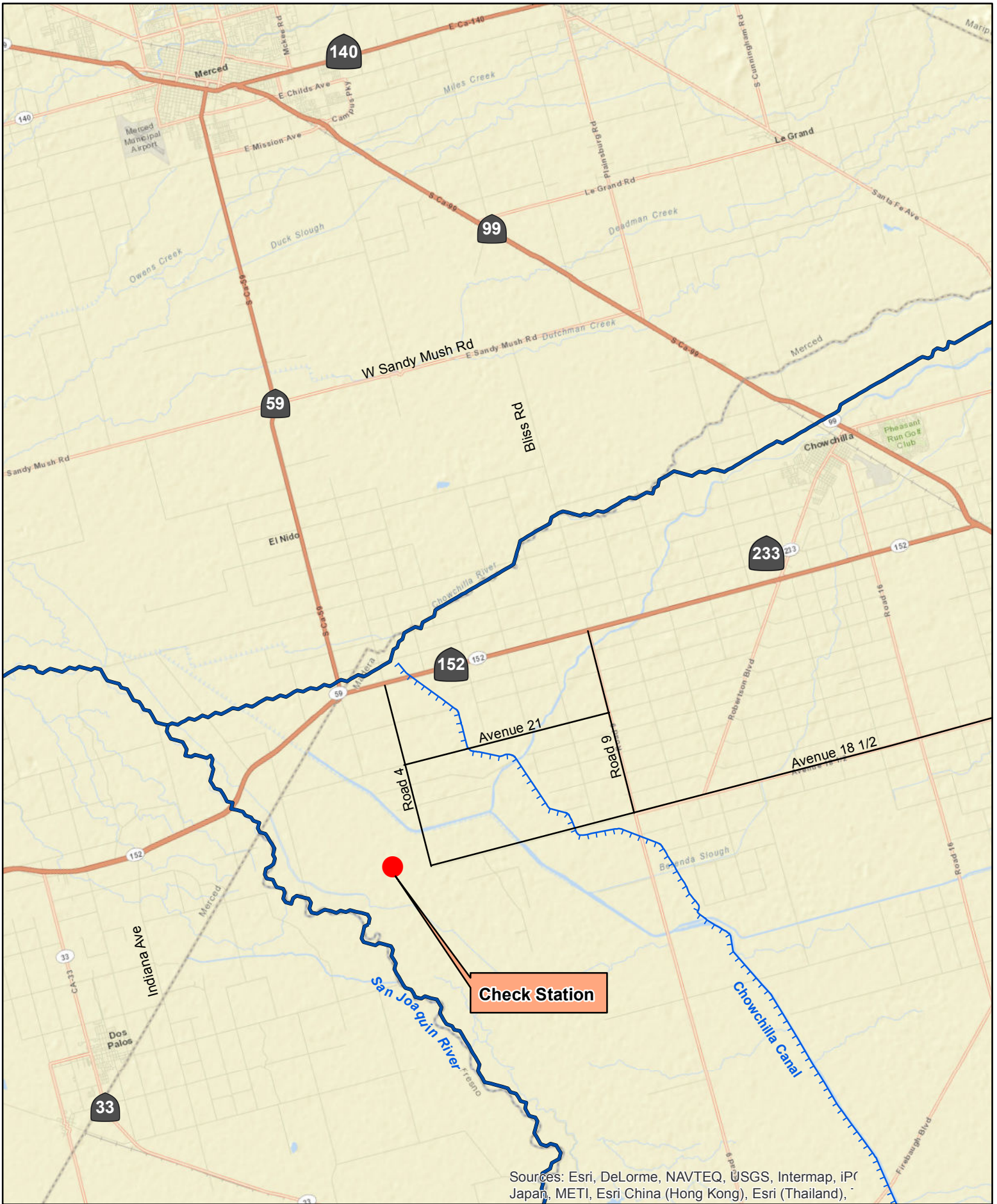
Please note the following rules and information pertaining to this hunt:

1. All hunters must possess a valid California hunting license. Adult hunters are required to have an Upland Game Bird Stamp.
2. Hunters under 18 years of age must be accompanied by an adult (18 years of age or older).
3. **Wearing shooting safety glasses and a blaze orange vest is required for all persons in the field.**
4. The daily bag limit is **two** male pheasants per hunter for this special hunt.
5. Hunters may be accompanied by non-shooters provided they obtain a free entry permit before entering the hunt area.
6. All hunting permits and non-shooting permits must be **returned** to the check station before leaving the hunting area.
7. The use of hunting dogs is permitted and encouraged.
8. Wearing bright hunter safety clothing is encouraged.



You are the guest of a private landowner, please respect his property. Do not climb fences or litter. Please pick up your empty shell cases. The future of this hunt depends on you.

The Ten Commandments of Firearms Safety:

1. Watch that muzzle! Keep it pointed in a safe direction at all times.
2. Treat every firearm with the respect due a loaded gun.
3. Be sure of your target and what is in front of it and beyond it.
4. Keep your finger outside the trigger guard until ready to shoot .
5. Check your barrel and ammunition.
6. Unload firearms when not in use.
7. Point your firearm only at something you intend to shoot.
8. Don't run, jump, or climb with a loaded firearm.
9. Store firearms and ammunition separately and safely.
10. Don't drink alcohol, use drugs or take medications that might impair your abilities and good judgment before or while handling firearms or archery equipment.

READ, INITIAL AND SIGN BEFORE HUNT DAY

Waiver of Potential Claims and Release of Liability

I, _____, as a condition of my being able to participate in hunting activities on State property acknowledge and represent to the State of California each of the following:

1. Hunting is an inherently dangerous activity that can result in serious injuries or death caused by myself or other people who are present, participating in or watching such activities. _____.

2. Hunting also includes an inherent risk of serious injury or death caused by conditions of the land, including both defects in or improvements thereto, or natural conditions including animals (whether those being hunted or not) on the property. The State has not made any representations that the conditions of the property are suitable for hunting or that the property is free from defects. _____.

3. I acknowledge that in allowing me to participate in hunting activities on State property, the State owes me no duty to supervise the activity or the persons participating in or watching the activity. I further acknowledge that by providing rules, signs, guides, chaperones or other volunteers to assist in hunting activities, neither the State, its agents, employees and/or volunteers owe me any duty whatsoever to supervise or control the actions of myself or other persons participating in, watching the activity or on the property. _____.

4. Waiver And Release Of Claims: I hereby expressly waive any right that I might have to sue the State, its agents, employees and/or volunteers for any physical or emotional injuries, illnesses, death or other damages that I might suffer as a result of participating in hunting activities on State property. _____.

5. Waiver And Release Of Claims Based On Negligence: In addition to the inherent dangers involved in hunting on State property described above, I further acknowledge that serious injuries or death may be caused by the negligent acts of State employees, its agents, volunteers or other persons which increase the risk of injury beyond those normally anticipated while hunting. I hereby expressly agree to assume the risk that I may be seriously injured or killed through the negligent acts of others. I agree to waive any right I may have to sue the State, its agents, employees and/or volunteers for injuries or death that I may suffer arising out of participating in hunting or related activities including physical or emotional injuries, illnesses or death caused by the negligent acts of the State, its agents, employees, volunteers or other persons. _____.

Prior to executing this waiver and release of liability, I was given the opportunity to thoroughly read the entire document and to consult my own legal counsel regarding the potential effect of signing this agreement. I hereby consent to be bound by its terms and conditions.

READ, INITIAL AND SIGN BEFORE HUNT DAY

Waiver of Minor's Potential Claims and Release of Liability

I, _____, am the legal parent/guardian of, _____, a minor under the age of 18 years (the "Child"), as a condition of the Child being able to participate in hunting activities on State property, I hereby acknowledge and represent to the State of California each of the following:

1. Hunting is an inherently dangerous activity that can result in serious injuries or death caused by myself, the Child or other people who are present, participating in or watching such activities. _____.

2. Hunting also includes an inherent risk of serious injury or death caused by conditions of the land, including both defects in or improvements thereto, or natural conditions including animals (whether those being hunted or not) on the property. The State has not made any representations that the conditions of the property are suitable for hunting or that the property is free from defects. _____.

3. I acknowledge that in allowing the Child to participate in hunting activities on State property, the State owes the Child no duty to supervise the activity or the persons participating in or watching the activity. I further acknowledge that by providing rules, signs, guides, chaperones or other volunteers to assist in hunting activities, neither the State, its agents, employees and/or volunteers owe the Child any duty to supervise or control the actions of the Child or other persons participating in, watching the activity or on the property. _____.

4. Waiver And Release Of Claims: I hereby expressly waive any right that the Child might have to sue the State, its agents, employees and/or volunteers for any physical or emotional injuries, illnesses, death or other damages that the Child might suffer as a result of participating in hunting activities on State property. _____.

5. Waiver And Release Of Claims Based On Negligence: In addition to the inherent dangers involved in hunting on State property described above, I further acknowledge that serious injuries or death may be caused by the negligent acts of State employees, its agents, volunteers or other persons which increase the risk of injury beyond those normally anticipated while hunting. I hereby expressly agree that the Child assumes the risk that the Child may be seriously injured or killed through the negligent acts of others. I agree to waive any right the Child may have to sue the State, its agents, employees and/or volunteers for injuries or death that the Child may suffer arising out of participating in hunting or related activities including physical or emotional injuries, illnesses or death caused by the negligent acts of the State, its agents, employees, volunteers or other persons. _____.

Prior to executing this waiver and release of liability, I was given the opportunity to thoroughly read the entire document and to consult my own legal counsel regarding the potential effect of signing this agreement. I hereby consent to be bound by its terms and conditions and consent to the Child being bound by its terms and conditions.
