



## Klamath Management Zone (OR/CA Border to Humboldt South Jetty)



**\*UPDATE\* August 2019**

### Commercial Ocean Salmon Fishery Information

The 2019 commercial ocean salmon fishery is scheduled to open in the California Klamath Management Zone (KMZ) between the Oregon/California border and Humboldt South Jetty **beginning Monday, August 12.**

- **Remaining Quota: 1,093 Chinook** (of the original 4,293 available)
- **Open Period: August 12-13, Monday through Tuesday**
  - **Potential remaining open days will be assessed on Thursday, August 15**
- **Daily landing and possession limit: 15 Chinook per vessel** ←

**All salmon caught must be landed within the area and within 24 hours of any closure of the fishery and prior to fishing outside of the area.**

#### **Other Fishery Requirements:**

- All salmon except coho.
- Minimum size limit: **27** inches total length.
- Single-point, single-shank barbless hooks are required.
- No more than 6 lines per vessel.
- Klamath Control Zone closed to commercial salmon fishing (12nm square centered on Klamath River mouth bounded on the north by 41°38'48" N. latitude; on the west, by 124°23'00" W. longitude; and on the south, by 41°26'48" N. latitude).
- Area directly outside the mouth of Humboldt Bay (3nm due west, 3nm north, and immediately south of Humboldt South Jetty) and outside the mouth of the Smith River (3nm due west, 3nm north, and 3nm south of mouth) closed to commercial salmon fishing - FG Code §8214, §8219.
- All salmon must be made available to Department staff for sampling and must relinquish the head from any salmon that has a missing adipose fin - FG Code §7702, §8226.
- It is unlawful to intentionally conceal, cull, or release into the waters, a salmon with a missing adipose fin that it is otherwise legal to possess - FG Code §8226.
- Vessels fishing south of Horse Mountain may not land fish in the KMZ unless the quota fishery has been closed at least 24 hours.
- All salmon landings must be submitted through the E-Tix application in a timely manner - Title 14, §197.
- Any person required to submit a landing through the E-Tix application shall include the total number of Chinook salmon landed in the "# of Fish" field - Title 14, §197.

#### **Incidental Pacific Halibut in Salmon Troll fishery open until Area 2A quota met\***

- The operator of a vessel that has been issued an International Pacific Halibut Commission (IPHC) incidental halibut harvest license may retain Pacific halibut caught incidentally in Area 2A while trolling for salmon.
- IPHC license holders may land or possess no more than one Pacific halibut per each two Chinook, except one Pacific halibut may be possessed or landed without meeting the ratio requirement.
- Minimum size limit: 32 inches total length with head on.
