

#### **EASY GUIDE TO USING THE BINDER**

- 1. Download and open the binder document using your Adobe Acrobat program/app.
- 2. If a bookmark panel does not automatically appear on either the top or left side of the screen, click/tap on the "bookmark symbol" located near the top left-hand corner.



3. To make adjustments to the view, use the Page Display option in the View tab. You should see something like:



- 4. We suggest leaving open the bookmark panel to help you move efficiently among the staff summaries and numerous supporting documents in the binder. It's helpful to think of these bookmarks as a table of contents that allows you to go to specific points in the binder without having to scroll through hundreds of pages.

This item is to provide the public an opportunity to discuss proposed changes for regulations for the 2020-21 seasons.

- (A) Mammal hunting: Annual proposed changes to hunting regulations for various big game mammals, including deer, Nelson bighorn sheep, antelope and elk, are generally combined for concurrent action under a single rulemaking package; DFW will present proposed changes, if any, during the meeting.
- (B) Waterfowl hunting: FGC annually adopts migratory waterfowl hunting regulations to conform State regulations with federal regulations; the U.S. Fish and Wildlife Service adopts federal regulations each Oct based, in part, on recommendations from four regional flyway councils. Migratory waterfowl include American coot, common moorhen, ducks, black brant and geese, among others; DFW will present proposed changes, if any, during the meeting.
- (C) Central Valley sport fishing: FGC annually adopts Central Valley Chinook salmon sport fishing regulations for the American, Feather, and Sacramento rivers to align State regulations with federal fishery management goals recommended by the Pacific Fishery Management Council (PFMC) (Exhibit C1).
- (D) FGC annually adopts Klamath River Basin sport fishing regulations to align State regulations with federal fishery allocations recommended by PFMC (Exhibit D1).

Today, DFW staff will summarize any proposed regulation changes beyond the anticipated changes to season and bag limits for the 2020-21 seasons.

This meeting is the last opportunity for WRC to make recommendations to FGC regarding potential changes to consider in these rulemakings before the notice hearing in Dec 2019.

#### Background

A DFW effort to comprehensively simplify inland sportfishing seasons and bag limits for trout waters (excluding anadromous waters) has been underway since 2018. See Exhibit 1 for a detailed background.

#### **Background**

Annually there are approximately two million non-native American bullfrogs and 300,000 nonnative turtles (mostly red-eared sliders and softshell turtles) imported into California for food and the pet trade. Even though these species are not imported into California with the intention of being released, they have established wild populations that threaten native amphibians, fish, and wildlife by direct predation, competition for resources and habitat, and disease. See Exhibit 1 for further background.

In Apr 2017, FGC directed FGC staff with DFW's assistance to develop a proposal for stakeholder engagement to further evaluate possible solutions to address the impacts of American bullfrogs and non-native turtles on native wildlife. The staff proposal was presented to FGC in Oct 2017, a revised version was approved by FGC in Oct 2018 (Exhibit 2), and the stakeholder engagement plan was referred to WRC in Dec 2018 to track progress in implementing the plan.

Today, staff will provide an update on progress since the May 2019 meeting, including interagency planning, convening of the environmental/animal welfare team and efforts to convene the industry team.




## 2020 Central Valley Salmon Sport Fishing Regulations

### 2019 Sport Fishing Regulations

- Lower American River
  - 2 fish daily bag / 4 fish possession limit
- Feather River
  - 2 fish daily bag / 4 fish possession limit
- Sacramento River
  - 2 fish daily bag / 4 fish possession limit
- Mokelumne River
  - 2 fish daily bag / 4 fish possession limit

## Increased Fishing Opportunities

- Feather River
  - extended the salmon fishing season by two weeks between the Thermalito Afterbay
     Outfall and the Live Oak boat ramp
- Mokelumne River
  - extended the salmon and hatchery steelhead fishing season on approximately ten miles of river between the Highway 99 Bridge and Elliott Road

### **2020 Regulatory Options**

- Option 1 Any size Chinook Salmon fishery
  - allow harvest of up to [0-4] salmon any size per day
- Option 2 Limited adult and grilse salmon fishery
  - allow harvest of a limited number of adult salmon, with grilse salmon making up the remainder of the daily bag and possession limits
- Option 3 Grilse-only salmon fishery
  - allow for a grilse-only salmon fishery

## Range of Possible Bag and Possession Limits

- Lower American River
  - Bag limit: 0-4 fish; Possession limit: 0-8 fish
- Feather River
  - Bag limit: 0-4 fish; Possession limit: 0-8 fish
- Mokelumne River
  - Bag limit: 0-4 fish; Possession limit: 0-8 fish
- Sacramento River
  - Bag limit: 0-4 fish; Possession limit: 0-8 fish



## Pacific Fisheries Management Council

- The PFMC establishes harvest allocations and natural spawning escapement goals for Klamath fall-run Chinook Salmon
- The PFMC will recommend the 2020 Klamath River recreational fishery allocation in April 2020
- Klamath Basin quota allocation typically conforms to PFMC recommendations (minimum of 15% of non-tribal allocation)
- DFW determines bag and possession limits based on quota

## 2019 Klamath River Basin Sport Fishing Regulations

- Klamath River Basin quota: 7,636 fish > 22 inches
- Daily bag limit: 3 fish, no more than 2 adults
   > 22 inches
- Possession limit: 9 fish, no more than 6 adults > 22 inches
- Season: Aug. 15 Dec. 31 (Klamath River)
- Season: Sept. 1 Dec. 31 (Trinity River)

## 2020 Klamath River Basin Regulatory Options

- Klamath River Basin quota range: 0-67,600 fish > 22 inches
- Bag limit range: 0-4 fish > 22 inches
- Possession limit range: 0-12 fish > 22 inches
- Season: Aug. 15 Dec. 31 (Klamath River)
- Season: Sept. 1 Dec. 31 (Trinity River)

## New Proposed Regulation Change

- Affected Water: Trinity River mainstem
- Affected Species: Brown Trout
- Proposal: Increase allowable harvest to 10 fish daily bag / 20 fish possession limit
- Justification: Allow for increased harvest of non-native trout

#### **Background**

For years, FGC and DFW have received complaints from anglers about the complexity of freshwater sport fishing regulations. Some anglers (or potential anglers) may be dissuaded from fishing due to actual or percieved difficulty in complying with the regulations. For example, currently there are 212 special regulation waters in Section 7.50(b), including 88 different seasons, 13 different size restrictions, 10 different gear restrictions, and 6 different bag and possession limits.

To help address angler concerns, DFW has proposed to change and simplify inland sportfishing seasons and bag limits, for trout waters only; the proposal excludes anadromous waters. The goals for the revisions are:

- maintain or increase angling opportunity;
- improve regulatory consistency across waters;
- align sport fishing regulations with DFW's fisheries management goals and objectives;
- reduce complexity and confusion; and
- protect fishery resources.

In basic terms, DFW designed a framework for the simplification based on a "menu" concept, where one of several predefined season and bag limit combinations would be chosen for specific waterways. In Jan 2019, DFW presented its proposed menu approach to WRC. In Feb 2019, FGC approved WRC's recommendation to support the menu concept, with an expectation that DFW would return to WRC with a more detailed proposal after public outreach meetings.

To date, DFW has held six outreach meetings across the state to solicit input from the public, and has received considerable feedback during and subsequent to the meetings. DFW is currently analyzing and integrating the feedback into its proposal. Today, DFW will update WRC on its efforts to date, outline its future plans for the proposal, and discuss implications for the overall timeline. FGC staff supports the additional effort DFW has made to reach and engage recreational fishermen across the state, and believes that such efforts will ultimately result in a proposal that can be more broadly supported during the rulemaking process.
