AB 1197 REVIEW

- Plan holders must identify a certified SMT capable of managing the RWCS volume listed in the plan
- OSPR must adopt regulations for certification process and requirements, including:
 - Geographic regions
 - On-scene time frames
 - Training
 - Objectives

RECAP OF LAST DRAFT

- Three tiers based on RWCS volumes
- SMT requirements for personnel on-scene times, training, and objectives split into Initial and Cascading phases
 - Initial Response Personnel on-scene within 8 hours, complete objectives checklist within 12 hours
 - Cascading Response Personnel on-scene within 24 hours, complete objectives checklist within 24 hours
 - Tiered training requirements are team-based for Initial and position-based for Cascading personnel

FEEDBACK ON LAST DRAFT

- Training requirements are still too robust; requirements for training should not be included in the regulations
 - HAZWOPER requirements are unnecessary
 - Training requirements do not allow for cross-training
 - Courses hard to get; more guidance needed on content of equivalent courses
 - Adding experience track was helpful, but requirements too great
- Contracted SMTs do not have PIOs on staff
- Timeframes for certification and renewal need adjustment to align with annual exercise scheduling

CHANGES IN RESPONSE TO FEEDBACK

- Several training courses were removed from requirements:
 - Tiers 1/2: ICS -320 Intermediate IMT, ICS-339 Div/Group Supervisor
 - Tier 3: Position-specific requirements; all have ICS-300
- HAZWOPER requirements for Cascading Personnel removed
- References to Type 2 exercises changed to Type 3
- Volume tested at certification exercises capped for Tier 1
- Defined the terms “Initial” and “Cascading” for purposes of the regulations; also modified relevant sections of the regulations to make intent more clear

CHANGES IN RESPONSE TO FEEDBACK

- Separate checklists for Initial and Cascading teams were combined into a single list with 6, 12, and 24 hour requirements
- Clarified minimum number of personnel required for Cascading teams: 12, 10, and 8
- Assistant PIOs not required of contracted SMTs
- Added section describing revisions, updates, renewals, and added content to clarify processes for application review and certification
- Removed much of the application content section to the draft applications; added confidentiality provisions
- Some sections were re-ordered for ease of reviewing

PROCESSES FOR APPLICATION, CERTIFICATION, EXERCISES

- Separate In-house and Contracted applications
- In-house away teams list C-plan numbers, Contracted SMTs list ACP, RPA coverage
- Application materials verified via appointments, unannounced exercises
- Certification exercises through OSPR's D&E program unless SMT requests otherwise
- SMTs apply for revisions, renewals through the application process
- Plan holders exclusively relying on external SMTs simply file an update to their contingency plans

NEXT STEPS

- Revise draft and complete rulemaking documentation
~Nov 2019
- Submit package to OAL for early review and feedback
~Dec 2019
- Revise and submit regulatory package ~Feb/Mar 2020
- Regulations go into effect within 90 days after Office of Administrative Law Approval ~Oct 1, 2020
