### IMPORTANT COMMITTEE MEETING PROCEDURES INFORMATION

Welcome to a meeting of the California Department of Fish and Wildlife (CDFW) Service Based Budgeting (SBB) External Advisory Committee (Committee). The goal of the Committee is to advise CDFW's SBB project team in conducting a service based budget review.

The Committee builds upon CDFW's Strategic Vision Stakeholder Advisory Group and has been assembled by CDFW SBB project leadership to comply with Fish and Game Code Section 712.1. The Committee represents a diverse range of fishing and hunting interests, non-profit conservation organizations, landowners, scientific and educational interests, and others dedicated to habitat conservation and the use and protection of public trust resources.

### PUBLIC COMMENT

The Committee follows the noticing requirements of the Bagley-Keene Open Meeting Act and will include opportunities for public comment. Comments during the public comment period shall be limited to matters within the scope of the SBB project.

### PERSONS WITH DISABILITIES
