



# Wolf Management Update

## Field Work

### Lassen pack

There were at least 6 wolves in the Lassen pack during the reporting period. The satellite collar on the female pup collared in September 2019 stopped functioning in late January after only about 4 months of operation. Currently there are no functioning radio collars in the pack.

### Dispersing wolves

#### **OR-54**

OR-54 was found dead in February. The mortality is under investigation. She first left her natal Rogue pack in southwest Oregon on January 23, 2018, and subsequently covered a minimum distance of 8,712 miles at an average of 13 miles/day. After dispersing, she spent most of her time in California but also returned to Oregon three times. She had 14 days where she traveled over 40 miles and 5 days where she traveled over 50 miles. In California, OR-54 spent time in Butte, Lassen, Modoc, Nevada, Plumas, Shasta, Sierra, Siskiyou, Tehama, and Yuba counties. She was a three-year-old wolf and the offspring of OR-7.

### **Big and Little Valley area survey**

There were 6 confirmed public detections (5 trail cameras, 1 visual) of single wolves between April 2018 and February 2019 in a broad area around Big Valley and Little Valley (near the junction of Lassen, Modoc, and Shasta counties). The area was surveyed thoroughly during the quarter to determine if a wolf pair or pack were occupying a territory. No sign was found.

## Livestock Interactions

### **Depredation investigations**

CDFW and USDA Wildlife Services (WS) staff investigated 2 reports of suspected wolf depredations during the quarter. The results are as follows:
