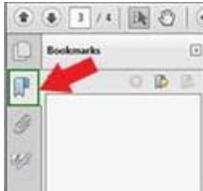

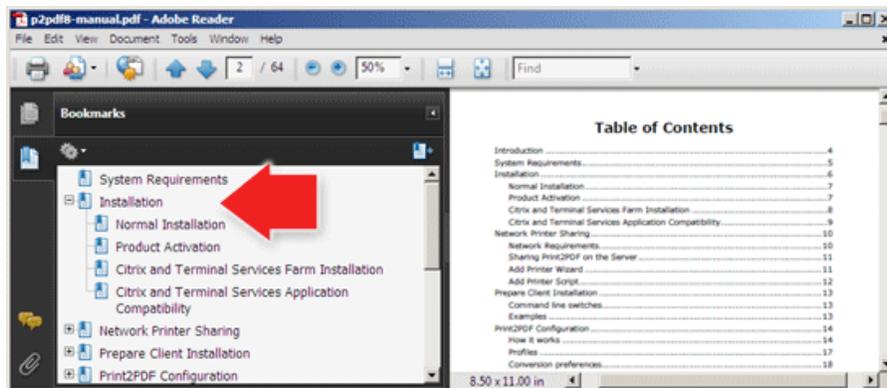
EASY GUIDE TO USING THE BINDER

Note: We make every effort to ensure that documents we produce are compliant with Americans with Disabilities Act standards, pursuant to state and federal law; however, some materials included in our meeting binders that are produced by other organizations and members of the public may not be compliant.

1. Download and open the binder document using your Adobe Acrobat program/app.
2. If a bookmark panel does not automatically appear on either the top or left side of the screen, click/tap on the “bookmark symbol” located near the top left-hand corner.



3. To make adjustments to the view, use the Page Display option in the View tab. You should see something like:



4. We suggest leaving open the bookmark panel to help you move efficiently among the staff summaries and numerous supporting documents in the binder. It's helpful to think of these bookmarks as a table of contents that allows you to go to specific points in the binder without having to scroll through hundreds of pages.
5. You can resize the two panels by placing your cursor in the dark, vertical line located between the panels and using a long click /tap to move in either direction. ⇄
6. You may also adjust the sizing of the documents by adjusting the sizing preferences located on the Page Display icons found in the top toolbar or in the View tab.
7. Upon locating a staff summary for an agenda item, notice that you can obtain more information by clicking/tapping on any item underlined in blue.
8. Return to the staff summary by simply clicking/tapping on the item in the bookmark panel.

Background

This item is to provide the public an opportunity to engage in initial discussions with the co-chairs, FGC staff and DFW about proposed changes for regulations for the following seasons:

- (A) Mammal hunting (2021-22): Proposed changes to hunting regulations for various big game mammals, including deer, Nelson bighorn sheep, antelope and elk.
- (B) Waterfowl hunting (2021-22): FGC annually adopts migratory waterfowl hunting regulations to conform State regulations with federal regulations. The U.S. Fish and Wildlife Service adopts federal regulations each Oct based, in part, on recommendations from four regional flyway councils. Migratory waterfowl include American coot, common moorhen, ducks, black brant and geese, among others.
- (C) Central Valley sport fishing (2021): FGC annually adopts Central Valley sport fishing regulations for the American, Feather, and Sacramento rivers to conform State regulations with federal regulations; future rulemakings will also include the Mokelumne River. The National Marine Fisheries Service (NMFS) adopts federal Central Valley salmon escapement goals each Apr based, in part, on recommendations from the Pacific Fishery Management Council (PFMC); .
- (D) Klamath River Basin sport fishing (2021): FGC annually adopts regulations to conform State regulations with federal regulations in the Klamath River Basin. NMFS adopts federal Klamath River Basin salmon allocations each Apr based, in part, on recommendations from PFMC.
- (E) Inland sport fishing: Inland sport fishing regulations include a wide variety of fish species in non-marine waters throughout the state of California. Today's discussion will include consideration of inland boat limits for finfish, based on a petition for regulation change (Petition #2018-014, Exhibit E1). While FGC denied the petition during initial consideration due to timing concerns, it asked DFW to consider the substance of the petition in the next inland sport fishing regulations package.

Background

Annually there are approximately two million non-native American bullfrogs and 300,000 non-native turtles (mostly red-eared sliders and softshell turtles) imported annually into California for food and the pet trade. Even though these species are not imported into California with the intention of being released, they have established wild populations that threaten native amphibians, fish, and wildlife by direct predation, competition for resources and habitat, and disease.

In Apr 2017, FGC directed FGC staff, with DFW's assistance, to develop a proposal for stakeholder engagement to further evaluate possible solutions to address the impacts of American bullfrogs and non-native turtles on native wildlife. The staff proposal was presented to FGC in Oct 2017, a revised version was approved by FGC in Oct 2018, and the stakeholder engagement plan was referred to WRC in Dec 2018 to track progress in implementing the plan. WRC received two progress updates in 2019 and one in 2020.

Today, staff will provide an update on progress since the Jan 2020 meeting, including a meeting of the agency team in April, outreach to importers, and an updated plan for completing the project.

2. Rulemaking Authority (Required) - Reference to the statutory or constitutional authority of the Commission to take the action requested: Authority Cited: Sections 200, ~~202~~265, and 7071 and ~~8587.1~~, Fish and Game Code. Reference: Sections ~~205~~, ~~210~~255, 7071 and 7120, Fish and Game Code.

3. Overview (Required) - Summarize the proposed changes to regulations: The Northern California Guides and Sportsmen's Association (NCGASA) is asking for an amendment to 27.60(c) relative to boat limits. 27.60 (c) currently allows, when two or more persons that are licensed or otherwise authorized to sport fish in ocean waters off California or in the San Francisco Bay District, defined in Section 27.00, are angling for finfish aboard a vessel in these waters, fishing by all authorized persons aboard may continue until boat limits of finfish are taken and possessed aboard the vessel as authorized under this section or Section 195, Title 14, CCR. The authorization for boat limits aboard a vessel does not apply to fishing trips originating in California's Sacramento Valley and Delta, creating a parity issue between bay and ocean fishing parties, and those who choose to fish inland, in the Delta, or other locations.

4. Rationale (Required) - Describe the problem and the reason for the proposed change: There is a parity issue between guided fishing trips in the bay and the ocean and those occurring inland (Delta and Sacramento Valley) when it comes to boat limits with two or more anglers on board. In the bay and ocean, ALL anglers may continue to fish, with their rods in the water, until boat limits of finfish are taken aboard. On guided trips inland, in the Delta and Sacramento Valley, once an angler has taken his/her limit of fish, that angler must REMOVE their rod from the river and sit in the boat until the other anglers have caught their limit. This can result in some anglers sitting idly in guides boats for hours on



end, reducing enthusiasm and willingness to participate in such activities in the future. NGCASA believes that our clients, who are abiding by all the same rules and regulations, and subject to the annual bag limits imposed by the Commission, should qualify for the same boat limits flexibility as bay and ocean fishing trips, allowing all anglers to continue pursuit until boat limits of finfish are taken. This issue was exacerbated in 2018 when the inland fishery bag limit for fall run salmon was reduced to 1 per person. This change, prompted by significant declines of returning adults, has led to a reduced interest in booking inland river guided trips. We are further exacerbating the situation by imposing the “you can only fish for your own fish” standard when the same does not apply to bay and ocean fishing. Many of our clients, who also fish those waters, are not familiar with the restriction, and don’t find out about it until they are sitting in our boats and we have to take their rods and tell them they are done for the day. Several have told us point blank that with a 1 per person limit, coupled with this restriction, that they would rather take their money and business to guided trips on the bay and ocean (please see the economic section below for further justification of this exact problem). Establishing boat limit parity for inland fisheries would create a more enjoyable experience for all parties involved, the anglers, sportsmen and women, fishing guides, and the communities that benefit from fishing tourism. It would also provide incentive for anglers to book fishing trips in the Sacramento Valley, especially with the restrictions of the 1 fish bag limit. (As an illustrative example, this regulation change would allow a father to hook a fish for his daughter, and hand it off to her to achieve her limit, while educating and teaching her the values of conservation and the pursuit of angling harvest).

Economic or Fiscal Impacts: Identify any known impacts of the proposed regulation change on revenues to the California Department of Fish and Wildlife, individuals, businesses, jobs, other state agencies, local agencies, schools, or housing: The following is an economic analysis on the impacts of a declining fishery on professional guides and the communities in which they do their business. NOTE: These numbers are just for the FALL RUN salmon season. It does not include stripers, late fall run, shad, sturgeon, steelhead, and rainbow trout. At the peak of the fishery in the early 2000's, it is estimated that guiding and associated industries brought in roughly \$55M for the counties of Sacramento, Shasta, Butte, Sutter, Yuba, Tehama, Glenn, and Colusa. Roughly \$30M of that was direct revenue for guide services. As the health of the fishery has declined, so to have the economics of the industry. By 2017 the industry had collapsed to a fraction of its former self, roughly \$14.5M in total and \$10.5M in direct guide revenue. How do we calculate these numbers? For direct guide revenue: There are currently 100 full time guides that guide 350 clients per year. There are 350 part time guides who guide 50 clients per year. This is a total of 52,500 clients. The average charge, per person, in 2017 was \$200/head. This is \$10.5M in revenue. For community revenue: Roughly 65% of clientele come from out of the area. At two beds per room per night (conservative assuming people share rooms), that's 34,125 clients in 17,062 hotel room nights. At \$100 per night, that's \$1.7M. For just those from out of town, calculate lunch and dinner at \$20 per meal for a total \$1,365M. Add breakfast at \$10 for a total of \$341,250. Assume 3 people travel per car and need one tank of gas, so that's 34,125 / 3 per car = 11,375 cars x \$60 fill up for a total of \$682,500 for fuel. That is the additional \$4M in community benefit. None of this accounts for revenue from fishing licenses to CDFW (either 1 day, 2 day, or annual licenses), bait, tackle, gear, tips, alcohol, additional entertainment (movies, shopping, etc). It also doesn't include guides expenditures in the community: buying fuel, gear, boat repairs, etc. Given how shocking the economic decline is between 2000 and 2017, it's even worse in 2018 with the newly imposed 1 fish bag limit. In 2018, everyone has dropped rates \$25 to \$50 to encourage bookings. Full timers did not drop prices as much, part-timers did more, but everyone is taking a haircut. In addition, bookings with guides, based on conservative estimates, are off at least 50%. Out of town visitors are simply not coming, considering 1 fish limit not worth the time and expense to book a fishing trip. Calculating the 2018 economic impact: Use an average rate of \$175 (\$200/head minus \$25 reduction) 100 full time and 350 part time guides, with a 50% decrease in bookings, direct guide revenue alone is down to \$4,593,750. Cut in half the number of hotel rooms, meals, gas and other incidentals and you start to see the impacts on the broader community. The total economic benefit estimate for 2018 is \$7,294,375, a 86% reduction from the early 2000's. Guides are losing homes, leaving their families behind (if they can) and guiding and fishing in OR, WA, AK, and ID to make money (roughly 15% of the guiding community have left). This data is compiled from NCGASA members (500+ guides) and their clients. Information was collected via direct guide surveys over phone, email, and Facebook polls.

Dear Wildlife Resources Committee,

This E-mail is sent to address Agenda item #4, "A" mammal hunting regarding options for the 2021-2022 hunting season. I would like you to give this serious consideration in advance of your September 2020 meeting when you begin considering allocating hunting tags for Roosevelt elk in Del Norte County.

I would like to bring to your attention that the DFW has identified 9 herds (I think that "herds" implies a larger number of elk, which is not the case) of Roosevelt elk in 2018 with a total population of 451. At that time, one herd had no bulls and no spikes. Another herd had 2 bulls and no spikes. There were 4 herds in the range of 3-5 bulls (and few or no spikes). The DFW repeated the count of Roosevelt elk in 2019 and counted a population of 403. That is a decrease of 48 elk in the time period of one hunting season. That is roughly a 10% reduction in the population of Roosevelt elk. At this time, there are 2 herds with no bulls and spikes (and no calves) counted. Somebody in the DFW called the population of Roosevelt elk "robust" and authorized an additional 18 Roosevelt elk to be hunted in the SHARE program in Del Norte County.

I wish to bring to your awareness that a population of 403 Roosevelt elk (in 9 herds) is not "robust" in my opinion; rather, a population this small is at high risk for poor gene pools and extinction. If you were to omit the number of calves and spikes from the population of 403 in 2019, that leaves only 245 cows and bulls. It appears that the thirst for blood that the hunters have for the Roosevelt elk in this area greatly exceeds the population available for them to kill. I would like to know why the WRC/FGC allows this? All one needs to do is look at an available population of 245, divide by 9 herds, will average 28 mature elk per herd. Further, the DFW permits more bulls to be killed per ratio of cows than the recommended or sustainable number. Why does the WRC/FGC allow this?

Still to come is the 2020-2021 hunting season. Given the data above, it looks like the DFW's projections are exacerbating the stress put on the bulls (and cows) in these small herds. Herds, in my opinion, that are too small to be hunted. None of this, slaughtering of Roosevelt elk (in these Del Norte County herds) could be done without your approval. Whatever recommendations are made by the DFW, I think it is your responsibility to check their math. Yes, the math of how many calves are in the population (and are not mature elk to hunt). And yes, the math regarding the ratio of bulls to cows in a herd. In all due respect, my experience with the DFW is that the DFW does not make accurate projections, rather than being conservative with issuing hunting tags; I see that the DFW is more than eager to provide more hunting tags to hunters.

Another consideration, the proposals made by the DFW are very deceptive. The DFW scatters there Roosevelt elk hunting allowances among 3 hunts: the general hunt, the PLM hunts, and the SHARE hunts. If the WRC/FGC is watching, then the WRC/FGC should know that the PLM and SHARE hunts are increasing at an unsustainable rate.. In 2016, 20 Roosevelt elk were killed in the SHARE program. In

2017, 27 Roosevelt elk were killed (a 30% increase). In 2019, 42 Roosevelt elk were killed; that is over twice as many Roosevelt elk killed just 3 years earlier. Is the population of Roosevelt elk doubling every 3 years, absolutely not! Thus, what kind of stewardship is the DFW providing for the Roosevelt elk herds? It is very questionable and troubling for me.

This E-mail is sent in advance of your meeting (in September) to consider hunting tags for Roosevelt elk, because I would like the FGC to have time to figure the math yourselves and to think about what is being done to our frail and fragmented herds in Del Norte County.

If any correspondence arrives after that date, it is considered late (and not included in the Commissioners' packets). This untimeliness, by the DFW, has happened to me numerous times resulting in my voice not being heard. It is a guaranteed right, in the US Constitution, for Americans to be able to express what concerns them. I bringing this to your attention, because I would like you to be aware of the DFW's tardiness and to hold them accountable to have their report available to the public 4 weeks before the FGC meeting (allowing the public to have prompt opportunity to send comments). Thank you.
