This form is required to be submitted to the Office of Spill Prevention and Response (OSPR) in accordance with Title 14, California Code of Regulations, section 830.7 for a provider of personnel to a plan holder's spill management team to become certified by the Office of Spill Prevention and Response. This form should be completed by a spill management team providing spill management services to a plan holder by contract or other approved means. ## Section C

Personnel listed in section D.2 shall have the training or other qualifications described in subsections 830.5(d) and (i) through (*I*), as applicable to the tier classification for which the applicant is requesting certification.
