

ADDITIONAL INFORMATION FOR THE NELSON SLOUGH FAMILY APPRENTICE PHEASANT HUNT

The Nelson Slough Unit is located 17 miles south of Yuba City and 23 miles north of Sacramento adjacent to the Feather River. Look for the Sacramento Avenue sign one mile north of the Feather River Bridge. Once at the levee follow the signs marked pheasant hunt.

The hunt will start with a pre-hunt registration at 7:45 AM for the 8:30 AM hunt. Reservations are good until 15 minutes before the hunt starts.

Each participant must provide an adult that is legally responsible for a participating Junior Hunter.

No dogs are provided for this hunt! Please plan to bring your own.

Please bring the following items to the hunt:

- A valid hunting license (drawn adults need an upland game bird stamp).
- **All shooters and non-shooters are required to wear shooting safety glasses with an ANSI rating of Z87.1 or above.** Glasses are available at most sporting goods stores.
- Appropriate hunting attire including thick jeans to ward off vegetation and be prepared for all weather. **A blaze orange hunting vest or similar safety attire is required for all persons in the field.**
- For safety, hunters must have a properly fitting shotgun.
- Bring non-lead low-base or high base shot shells, size 6, or 7 1/2 shot only. No magnum loads are allowed. All hunters may have only one (1) shot shell in the magazine or chamber while hunting. **Only non-lead ammunition will be allowed for this hunt.**
- Bring your own food and drinks.

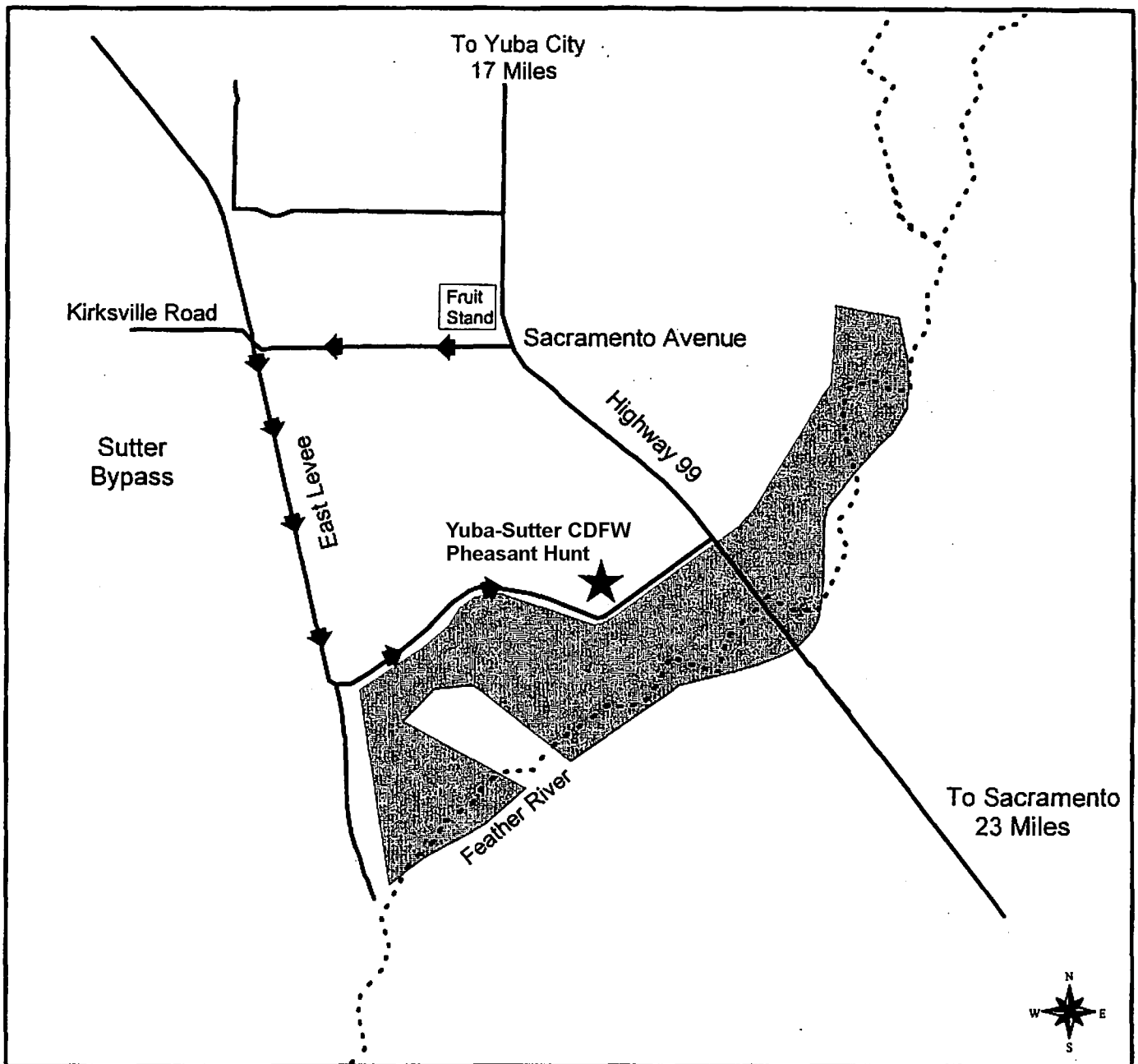
Please leave your firearm in your vehicle until after the hunter orientation and assignment to the hunting field.

REMEMBER: Bring your own dog (or hunt without one), your own ammo (DFW cannot provide ammo), safety glasses, and an orange hunter vest.

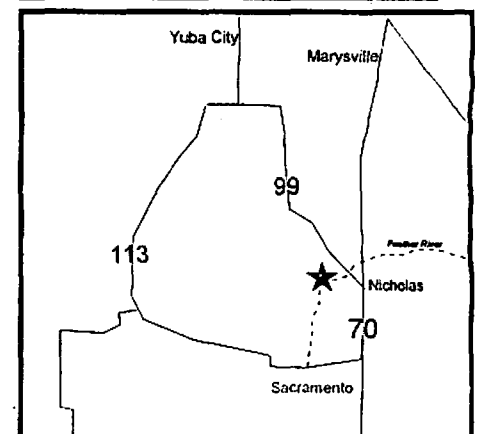

From Yuba City: Take Highway 99 South to the Sacramento Avenue exit. Go right (West) on Kirksville Road for about a mile until you come to the levee road. Turn left on the levee and follow signs to next turn. Proceed to parking lot.

From Sacramento: Take Highway 99 North to the Sacramento Avenue exit. Go left (West) on Kirksville Road for about a mile until you come to the levee road. Turn left on the levee and follow signs to the next turn. Proceed to parking lot.



The Ten Commandments of Firearms Safety:

1. Watch that muzzle! Keep it pointed in a safe direction at all times.
2. Treat every firearm with the respect due a loaded gun.
3. Be sure of your target and what is in front of it and beyond it.
4. Keep your finger outside the trigger guard until ready to shoot .
5. Check your barrel and ammunition.
6. Unload firearms when not in use.
7. Point your firearm only at something you intend to shoot.
8. Don't run, jump, or climb with a loaded firearm.
9. Store firearms and ammunition separately and safely.
10. Don't drink alcohol, use drugs or take medications that might impair your abilities and good judgment before or while handling firearms or archery equipment.

Waiver And Release Of Claims: I hereby expressly waive any right that I might have to sue the State, its agents, employees and/or volunteers for any physical or emotional injuries, illnesses, death or other damages that I might suffer as a result of participating in hunting activities on State property. _____.

Waiver And Release Of Claims Based On Negligence: In addition to the inherent dangers involved in hunting on State property described above, I further acknowledge that serious injuries or death may be caused by the negligent acts of State employees, its agents, volunteers or other persons which increase the risk of injury beyond those normally anticipated while hunting. I hereby expressly agree to assume the risk that I may be seriously injured or killed through the negligent acts of others. I agree to waive any right I may have to sue the State, its agents, employees and/or volunteers for injuries or death that I may suffer arising out of participating in hunting or related activities including physical or emotional injuries, illnesses or death caused by the negligent acts of the State, its agents, employees, volunteers or other persons. _____.
