### **ADDITIONAL INFORMATION**

**Effective July 1, 2019, nonlead ammunition is required when taking any wildlife with a firearm anywhere in California. Please plan accordingly.**

Hunters must possess a valid California hunting license and upland game bird validation. Hunters possessing a junior hunting license do not need an upland game bird validation and must be accompanied by a non-shooting adult 18 years of age or older. All shooters and non-shooters must wear shooting safety glasses, blaze orange, and initial and sign the enclosed waiver.

Please come prepared and wear appropriate gear for the hunt; we strongly recommend you bring water, a hat, sturdy shoes/boots, sweater/jacket, mosquito repellent and a cooler with ice for your birds. For safety, Apprentice hunters must have a properly fitted shotgun. Please note if you are not prepared for the hunt or your gear is deemed unsafe you may be asked to withdraw from the hunt.

The Upland Game Bird Special Hunts Program is pleased to offer you this special hunt. Practice good sportsmanship, enjoy your hunt and most of all, be a safe hunter.

Listed below are special rules and information for the hunt:

**COVID 19 PROTOCOLS:**

PLEASE FOLLOW ALL CDC AND LOCAL GUIDELINES WHILE PARTICIPATING IN THE JUNIOR HUNT. DO NOT GATHER IN LARGE GROUPS, WEAR MASKS, STAY IN OR BY YOUR VEHICLE UNTIL CALLED UP FOR REGISTRARTION OR ORIENTATION OR WHEN NOT HUNTING. FAILURE TO COMPLY MAY RESULT IN THE CANCELATION OF THIS OR FUTURE HUNTS BY COUNTY OR STATE OFFICALS. DO YOUR PART, AND BE WELL.

1. Permits will be issued to you and the person who will be accompanying you on the hunt when you check-in with Department of Fish and Wildlife personnel. **Only one non-hunting adult, 18 years or older, must accompany no more than two junior hunters in the field.** The adult who is accompanying the junior hunter(s) may NOT possess any weapon and may NOT hunt under any circumstances. The adult accompanying the junior hunter(s) will be in a supervisory capacity only. No other persons except a volunteer dog handler if available will be allowed in the field with the junior hunter(s) and the one accompanying adult.

2. All persons in the field are required to provide and wear shooting safety glasses.

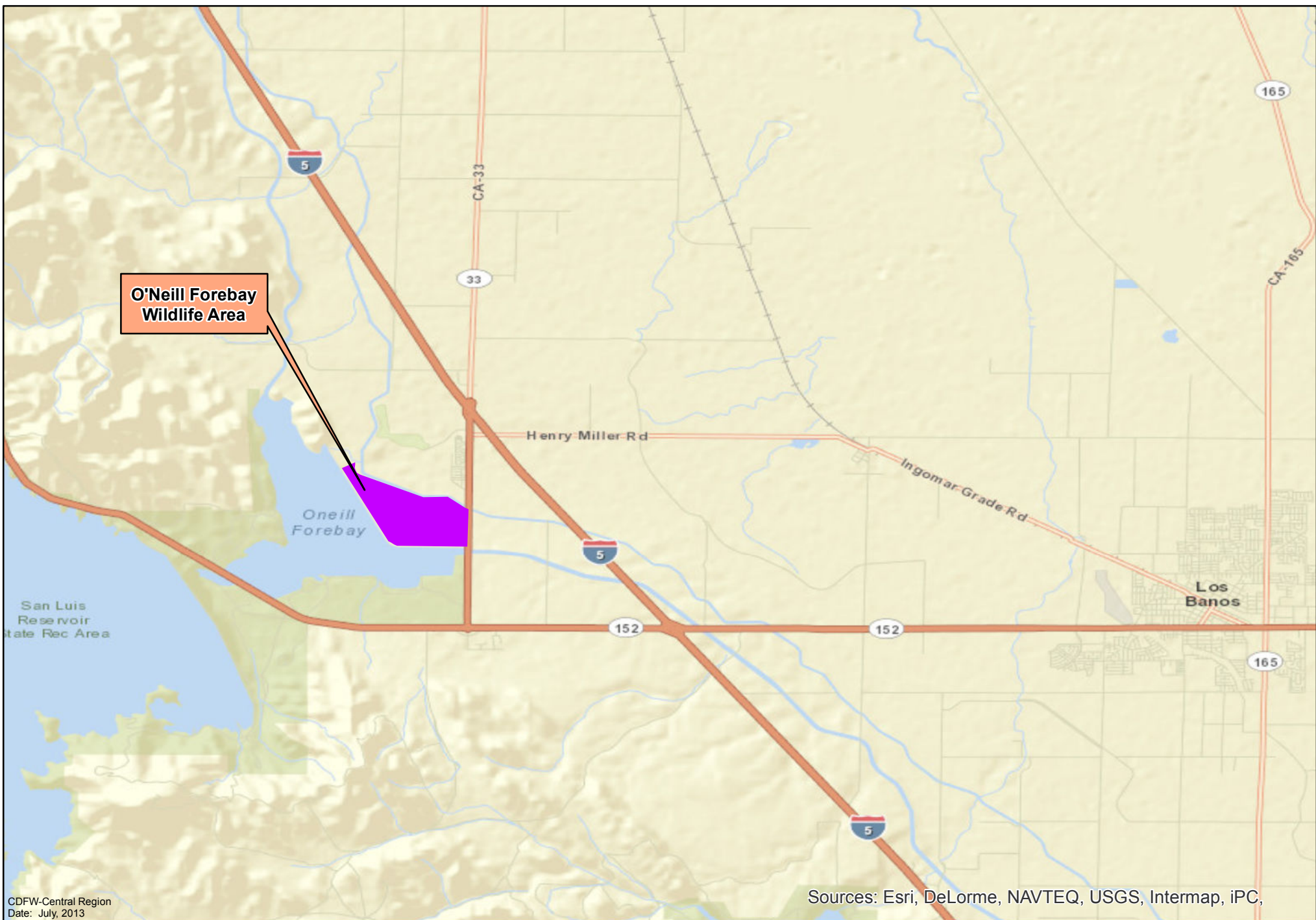
**3. Lead shot may NOT be used to hunt pheasants and upland game.** An upland game stamp is NOT required for junior license holders. The use of dogs is permitted and desirable.

4. Rules and regulations of the Department of Fish and Wildlife will be in effect. Each hunter is limited to taking two (2) rooster pheasant during the hunt.

5. Hunts will not be canceled due to bad weather.

6. It is suggested that bright colored clothing and comfortable walking footwear be worn. Blaze orange vests will be provided by the department at the time you check- in. All permits must be returned before leaving the area.

## **The Ten Commandments of Firearms Safety:**

1. Watch that muzzle! Keep it pointed in a safe direction at all times.
2. Treat every firearm with the respect due a loaded gun.
3. Be sure of your target and what is in front of it and beyond it.
4. Keep your finger outside the trigger guard until ready to shoot .
5. Check your barrel and ammunition.
6. Unload firearms when not in use.
7. Point your firearm only at something you intend to shoot.
8. Don't run, jump, or climb with a loaded firearm.
9. Store firearms and ammunition separately and safely.
10. Don't drink alcohol, use drugs or take medications that might impair your abilities and good judgment before or while handling firearms or archery equipment.





## READ, INITIAL AND SIGN BEFORE HUNT DAY

### Waiver of Potential Claims and Release of Liability

1. Hunting is an inherently dangerous activity that can result in serious injuries or death caused by myself or other people who are present, participating in or watching such activities. \_\_\_\_\_.

Hunting also includes an inherent risk of serious injury or death caused by conditions of the land, including both defects in or improvements thereto, or natural conditions including animals (whether those being hunted or not) on the property. I acknowledge that in allowing me to participate in hunting activities on State property, the State owes me no duty to supervise the activity or the persons participating in or watching the activity. I further acknowledge that by providing rules, signs, guides, chaperones or other volunteers to assist in hunting activities, neither the State, its agents, employees and/or volunteers owe me any duty whatsoever to supervise or control the actions of myself or other persons participating in, watching the activity or on the property. \_\_\_\_\_.

4. Waiver And Release Of Claims: I hereby expressly waive any right that I might have to sue the State, its agents, employees and/or volunteers for any physical or emotional injuries, illnesses, death or other damages that I might suffer as a result of participating in hunting activities on State property. \_\_\_\_\_.

5. Waiver And Release Of Claims Based On Negligence: In addition to the inherent dangers involved in hunting on State property described above, I further acknowledge that serious injuries or death may be caused by the negligent acts of State employees, its agents, volunteers or other persons which increase the risk of injury beyond those normally anticipated while hunting. I hereby expressly agree to assume the risk that I may be seriously injured or killed through the negligent acts of others. I agree to waive any right I may have to sue the State, its agents, employees and/or volunteers for injuries or death that I may suffer arising out of participating in hunting or related activities including physical or emotional injuries, illnesses or death caused by the negligent acts of the State, its agents, employees, volunteers or other persons. \_\_\_\_\_.

## READ, INITIAL AND SIGN BEFORE HUNT DAY

### Waiver of Minor's Potential Claims and Release of Liability

I acknowledge that in allowing the Child to participate in hunting activities on State property, the State owes the Child no duty to supervise the activity or the persons participating in or watching the activity. I further acknowledge that by providing rules, signs, guides, chaperones or other volunteers to assist in hunting activities, neither the State, its agents, employees and/or volunteers owe the Child any duty to supervise or control the actions of the Child or other persons participating in, watching the activity or on the property. \_\_\_\_\_.

Waiver And Release Of Claims: I hereby expressly waive any right that the Child might have to sue the State, its agents, employees and/or volunteers for any physical or emotional injuries, illnesses, death or other damages that the Child might suffer as a result of participating in hunting activities on State property. \_\_\_\_\_.

Waiver And Release Of Claims Based On Negligence: In addition to the inherent dangers involved in hunting on State property described above, I further acknowledge that serious injuries or death may be caused by the negligent acts of State employees, its agents, volunteers or other persons which increase the risk of injury beyond those normally anticipated while hunting. I hereby expressly agree that the Child assumes the risk that the Child may be seriously injured or killed through the negligent acts of others. I agree to waive any right the Child may have to sue the State, its agents, employees and/or volunteers for injuries or death that the Child may suffer arising out of participating in hunting or related activities including physical or emotional injuries, illnesses or death caused by the negligent acts of the State, its agents, employees, volunteers or other persons. \_\_\_\_\_.
