

# 2024 COMMERCIAL FISHING VESSEL ITEMS AND FEES

Fee includes 5% License Agent Handling Fee and 3% Nonrefundable Application Fee

### **COMMERCIAL FISHING VESSEL REGISTRATIONS**

Required for any resident or non-resident owner, or operator for any vessel operated in public waters in connection with fishing operations for profit in this State; or which, for profit, permits persons to sport fish.

Commercial Boat Registration (CBR) Resident	\$490.50
Commercial Boat Registration (CBR) Nonresident	1,457.05

### COMMERCIAL NONRESTRICTIVE VESSEL PERMITS

Before non-restrictive commercial fishing vessel permits can be issued, an applicant must possess a valid commercial fishing vessel registration (resident or non-resident).

### **COMMERCIAL LIMITED ENTRY VESSEL PERMITS**

Limited Entry Vessel Permits are issued only to pre-qualified commercial vessel owners. "Limited entry fishery" means a fishery in which the number of persons who may participate or the number of vessels that may be used in taking a specified species of fish is limited by statute or regulation.
