## **Background**

FGC currently conducts its business at six two-day meetings (Feb, Apr, Jun, Aug, Oct and Dec) on a Wednesday and Thursday, plus a teleconference meeting in May and others as needed. Committees each generally hold three (half-day to fullday) meetings per year. In 2021, committee meetings were held either staggered and alternating between FGC business meetings (WRC on Thursdays in Jan, May and Sep, MRC on Tuesdays in Mar, Jul and Nov), or the afternoon before the first day of three FGC meetings (TC on Tuesdays). Staff seeks guidance on whether to retain the same months and days of week for FGC and committee meetings.

With the planned Jun 15 re-opening of the California economy and fewer budget constraints limiting travel in the new fiscal year, FGC staff is preparing to resume holding meetings throughout the state in 2022. Staff has drafted a list of proposed 2022 meeting dates and locations for FGC consideration and discussion today (Table 1).

Adequate meeting facilities have become more difficult to secure and advanced planning increases the likelihood of locating suitable and available venues. Thus, to ensure staff has adequate time to identify and secure venue options that meet FGC's requirements related to cost, information technology and security conditions, as well as State-mandated bids, contracting conditions and timelines, it is important for meeting dates and locations to be identified many months in advance.

Staff developed the proposed meeting dates taking into account State holidays, other relevant meeting schedules, and regulatory deadlines. For this year's FGC meetings, wildlife/inland fisheries items are heard the first day, and marine items are heard the second day. For 2022, rotating the subject matter is recommended such that marine items are heard on the first day, and wildlife/inland fisheries items on the second day.

Staff anticipates that FGC will continue to hold meetings by webinar and teleconference at least through Aug 2021 and, ultimately, a hybrid in-person/teleconference format may be employed. Staff is working with FGC's current audio-visual contractor to explore options and costs for hybrid meetings.
