Background

MRC works under FGC direction to set and accomplish its work plan.

Committee Work Plan

Topics that have been referred by FGC to MRC are displayed in a work plan (Exhibit 1) for scheduling and tracking.

New MRC Topics

During the May 2021 FGC teleconference meeting, a commenter expressed concern about observed declines in abundance of *Polstelsia*, a marine algal species known as sea palm that is commercially harvested as edible seaweed, in long-term monitoring data sets. The commenter requested that FGC schedule discussion at the Jul MRC meeting and explore potential regulation changes for sea palm commercial harvest as a precautionary response to abundance declines.

Review of regulations for commercial harvest of all edible seaweed species, including sea palm, is currently scheduled as the second phase of the MRC work plan topic "kelp and algae commercial harvest regulations review." The first phase, focused on bull kelp only due to its immediate, precipitous declines, is scheduled for recommendation at the Jul 2021 MRC meeting; the second phase will resume in Nov 2021. The commenter is concerned that sea palm has declined and also needs immediate attention.

Since the request in May, FGC staff has conferred with the requester and DFW. Discussions with relevant researchers, as well as a collaborative review of the data, gaps, and interpretation are underway.

Staff believes that a discussion about sea palm would be better suited for the Nov 2021 MRC meeting, so it can be held concurrently with a planned review of edible algae commercial harvest regulations; this will also provide time for DFW to evaluate the available monitoring data to support discussion and potentially provide a recommendation.
