## NOTICE OF 15-DAY PUBLIC COMMENT PERIOD FOR MODIFICATIONS TO TEXT OF PROPOSED REGULATIONS AND ADDITION OF DOCUMENTS AND INFORMATION TO RULEMAKING FILE

August 12, 2021

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the Office of Spill Prevention and Response (OSPR), is providing this 15-day notice of changes made to proposed amendments to sections 791.7 and 793 within Title 14, California Code of Regulations, pertaining to the fee assessed against non-tank vessels. Section 870.17 is also being included, although no additional substantive changes to this section are being proposed. Additionally, changes are made to the Application for Certificate of Financial Responsibility for Owners or Operators of Nontank Vessels, DFW 1972 (Rev. 07/21), which is being incorporated by reference in the proposed regulations.

Pursuant to the requirements of Government Code sections 11346.8(d), 11346.9(a)(1), and 11347.1, OSPR is also providing notice that documents and other information which OSPR has relied upon in adopting the proposed regulations have been added to the rulemaking file and are available for public inspection and comment. The following studies, reports, or documents relied upon are added to the rulemaking file:
