


Figure 2: Reported mountain lion incidents by county




Figure 3: Temporal comparison of Statewide number of HWC incidents involving Mountain Lions in 2015-2017




Figure 4: Temporal comparison of the proportion of response types by CDFW staff to all Statewide incidents involving Mountain Lions from 2015-2017




Figure 5: Temporal comparison of the number of HWC incidents involving Mountain Lions in Northern Region counties in 2015-2017




Figure 6: Temporal comparison of the number of HWC incidents involving mountain lions in the Northern Region in 2015-2017




Figure 7: Temporal comparison of the number of HWC incidents involving mountain lions in North Central Region counties in 2015-2017




Figure 8: Temporal comparison of the number of HWC incidents involving mountain lions in the North Central Region in 2015-2017




Figure 9: Temporal comparison of the number of HWC incidents involving mountain lions in Bay Delta Region counties in 2015-2017




Figure 10: Temporal comparison of the number of HWC incidents involving mountain lions in the Bay Delta Region in 2015-2017




Figure 11: Temporal comparison of the number of HWC incidents involving mountain lions in Central Region counties in 2015-2017




Figure 12: Temporal comparison of the number of HWC incidents involving mountain lions in the Central Region in 2015-2017




Figure 13: Temporal comparison of the number of HWC incidents involving mountain lions in South Coast Region counties in 2015-2017




Figure 14: Temporal comparison of the number of HWC incidents involving mountain lions in the South Coast Region in 2015-2017




Figure 15: Temporal comparison of the number of HWC incidents involving mountain lions in Inland Deserts Region counties in 2015-2017




Figure 16: Temporal comparison of the number of HWC incidents involving mountain lions in the Inland Deserts Region in 2015-2017




Figure 17: Temporal comparison of the number of HWC incidents involving mountain lions for the Wildlife Investigations Lab (WIL) in 2015-2017.
