### ADDITIONAL INFORMATION

You have been drawn for the Green Gulch Ranch pheasant hunt sponsored by the California Department of Fish and Wildlife. Your hunt will be held on Sunday, November 7, 2020. Check in time is 8:30 am for the morning hunt to ensure enough time to process paperwork.

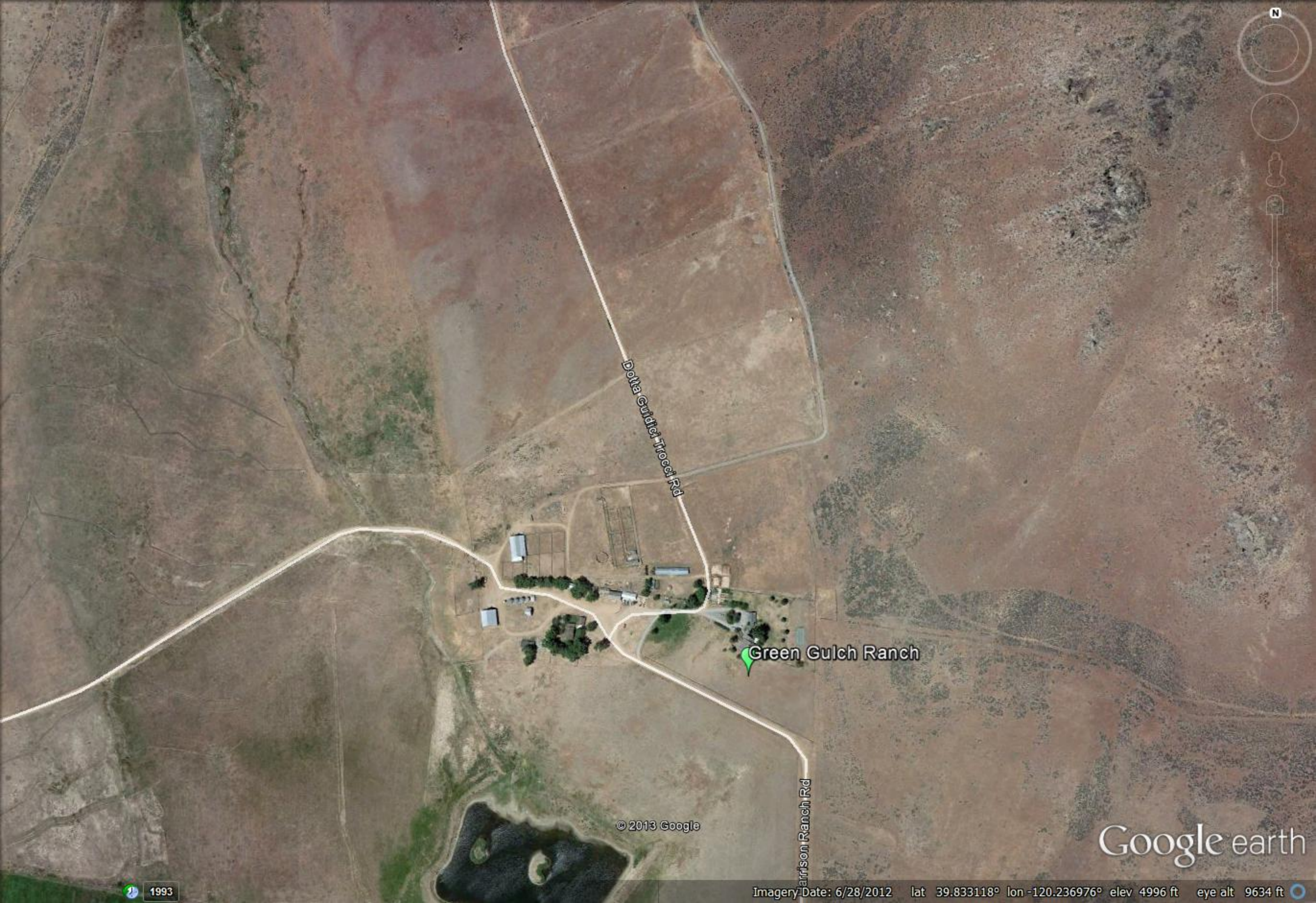
You must present this letter, along with a California Hunting license to the check station leader to receive your entry permit. In response to the current COVID pandemic we ask that, upon arrival to Green Gulch Ranch, you park in designated area and wait to receive further instructions.

Hunters must have a valid California hunting license and Upland Game Bird Stamp (Juniors do not need an Upland Game Bird Stamp). Junior hunters must be accompanied by a non-shooting adult 18 years of age or older. All shooters and non-shooters must wear shooting safety glasses, blaze orange, and initial and sign the enclosed waiver.

Please come prepared and wear appropriate gear for the hunt; we strongly recommend you bring water, a hat, sturdy shoes/boots, sweater/jacket, mosquito repellent and a cooler with ice for your birds. For safety, Apprentice hunters must have a properly fitting shotgun. Please note if you are not prepared for the hunt or your gear is deemed unsafe you may be asked to withdraw from the hunt. **Trained dogs will be provided, please do not bring dogs.**

Practice good sportsmanship, be a safe hunter and most of all enjoy your hunt! If you require any special accommodations, cannot attend this hunt, or have any questions please contact the Department of Fish and Wildlife at (530) 624-8657.

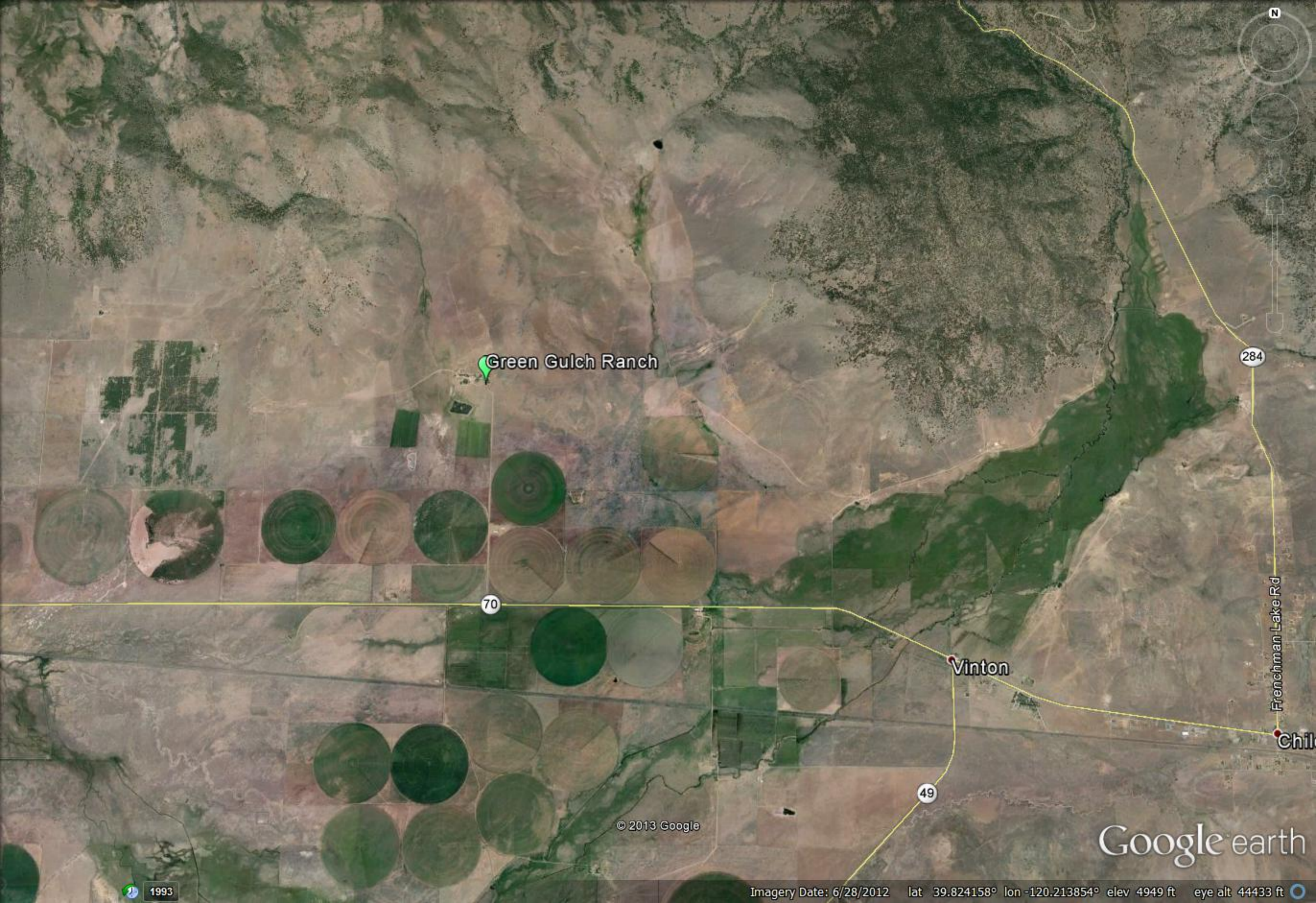
