SUBJECT: FOURTH RELEASE OF CREDITS FOR THE BULLOCK BEND MITIGATION BANK (1798-2014-01-R2)

Dear Ms. Collins:

The California Department of Fish and Wildlife (CDFW) has received your letter requesting the fourth release of credits for the Bullock Bend Mitigation Bank (Bank).

Per Section VII.B of the Bank Enabling Instrument (BEI), 15% of the total amount of credits can be released upon attainment of year 3 performance standards, funding of the endowment principal in accordance with Section VI.E.2.a of the BEI, and approval of National Marine Fisheries Service (NMFS) and CDFW. The performance measures for year 3 have been attained, the endowment has been funded in accordance to the BEI, and per NMFS email dated February 27, 2020, NMFS concurred the performance standards were achieved. Since all the requirements have been achieved, CDFW authorizes per Exhibit F, the release of the following credits:
