How to Join the Meeting (to watch or participate)

# **General participation instructions**

## **Viewing Presentations**

If you join via Zoom on your computer or mobile device app (Options 1, 2, and 4) the presentations will be displayed. If you join via teleconference only (Option 3), you can view a PDF of the presentations in the <u>meeting binder</u>.

## Participating in the Meeting

If you join via Zoom on your computer or mobile phone app (Options 1, 2, and 4) use the "raise hand" feature to indicate that you would like to make a comment.

If you join via teleconference only (Option 3), press "\*9" to virtually raise your hand to indicate you would like to make a comment; if you press \*9 again, you will *lower* your hand.

When the moderator unmutes you to make a comment, you may need to unmute yourself as well.
