Background

(A) Receive New Petitions for Regulation Change

Pursuant to Section 662, any person requesting that the Commission adopt, amend, or repeal a regulation must complete and submit form FGC 1. Regulation change petition forms submitted by the public are received at this Commission meeting under (A) if they are delivered by the comment deadline (included in meeting materials) or by the supplemental comment deadline.

Under the Bagley-Keene Open Meeting Act, the Commission cannot discuss or take action on any matter not included on the agenda, other than to schedule issues raised by the public for consideration at future meetings. Thus, petitions for regulation change generally follow a two-meeting cycle (receipt and direction); the Commission will determine the outcome of the petitions for regulation change received at today's meeting at the next regularly scheduled Commission meeting (currently April 19-20, 2023) under (B), following staff evaluation, unless the petition is rejected under 10-day staff review as prescribed in subsection 662(b).

The Commission received one new petition by the comment deadline; the petition is summarized in Exhibit A1 and provided as Exhibit A2.

(B) Action on Previously-Received Petitions for Regulation Change

Petitions received at the previous meeting are scheduled for Commission consideration at the next regularly scheduled business meeting under (B). A petition may be (1) denied, (2) granted, or (3) referred to a committee, staff, or the Department for further evaluation

or information-gathering. Referred petitions are scheduled for action once the evaluation is completed and a recommendation made.

27.40. CENTRAL GROUNDFISH MANAGEMENT AREA. This Section applies to take and possession of federally-managed groundfish species as defined in Section 1.91, California sheephead, ocean whitefish, and all greenlings of the genus Hexagrammos. For specific definitions, applicability, and procedures, see sections 1.91 and 27.20. For size limits, possession limits, and other regulations that apply to individual species, see specific sections beginning with Section 27.60.

(a) The Central Groundfish Management Area means ocean waters between 37° 11' N. lat. (at Pigeon Point, San Mateo County) and 34°27' N. lat (at Point Conception, Santa Barbara County).

(b) Seasons and depth constraints (except as provided in subsection (c) below):

(1) January 1 through March 31: Closed.

(2) April 1 through December 31: Take of all species is prohibited seaward of a line approximating 34 For up-to-date groundfish and Pacific halibut regulation information, call the CDFW Groundfish Hotline at (831) 649-2801 For up-to-date ocean salmon regulation information, call the CDFW Ocean Salmon Hotline at (707) 576-3429 the 50-fathom depth contour along the mainland coast and along islands and offshore seamounts. depth contour is defined by straight lines connecting the set of 50-fathom waypoints as adopted in Federal regulations (50 CFR Part 660, Subpart C).

- (c) Leopard shark may be taken or possessed in Elkhorn Slough year-round.
- (d) Take of all species is prohibited shoreward of a line approximating 100 feet.

4. **Rationale (Required) -** Describe the problem and the reason for the proposed change:

California's Central Coast kelp forests are in rapid decline due to multiple stressors and in need of restoration if they are to continue to support the hundreds of species that live therein. The Marine Protected Area experiment proved that when fish are not taken from an area the kelp does better and species richness increases. Let's do that! Our best chance of increasing kelp survivorship is to not fish in this ecosystem and remove functioning parts indiscriminately. The diving community is actively trying to improve kelp survivorship by removing urchins that are eating kelp and it is not fair and equitable for our community to be improving kelp survivorship while licensed individuals actively work to be detrimental.

Prohibiting fishing in the nearshore fish nursery also improves the sustainability of fishing and provides better fishing opportunities. Fishing should be available to all regardless of socioeconomic status and an exception should be allowed to fish from shore on sandy habitat 300 feet away from rocky reefs. Fishermen may also assist with kelp restoration by acting as citizen science volunteers working under Scientific Collecting Permits to sample fish as determined by the Department.

This increases the risk of gear loss and whale entanglements. Also, it is more difficult to sight and gaff/retrieve only one buoy during times of rough seas.
