

## **2023 Salmon Information Meeting Instructions and Guidelines**

The 2023 Salmon Information Meeting marks the beginning of a two-month long public process used to develop annual sport and commercial ocean salmon fishing regulations. The process involves collaborative negotiations with west coast states, federal agencies, tribal comanagers, and stakeholders interested in salmon fishery management and conservation. Public input will help California representatives develop a range of recommended season alternatives during the March 5-10, 2023, meeting of the Pacific Fishery Management Council. Final season regulations will be adopted at the April 1-7 Pacific Fishery Management Council meeting.

### **Meeting Objectives**

- Provide a review of 2022 ocean and river fisheries
- Provide a review of 2022 inland escapement
- Provide an overview of 2023 ocean abundance forecasts
- Collect public input on potential 2023 ocean salmon fisheries

Raise your hand if you want to ask a question about a presentation, or make a comment during the public listening session. Instructions to do this through the virtual platform or via phone below:
