- Operational Updates
 - CVP: No changes in releases since last week. Trinity River releases are at 300 cfs. Sacramento River (Keswick) releases are at 3,250 cfs. Clear Creek (Whiskeytown) releases are at 200 cfs. American River (Nimbus) releases are at 1,300 cfs. Stanislaus River (Goodwin) releases are at 200 cfs. Reclamation's Delta pumping is at 2 units targeting 1,800 cfs. Tomorrow, planning for 3 units

targeting 2,700 cfs to capture water from last weekend's storm. Federal share of San Luis Reservoir is 204 TAF.

- SWP: Feather River (Oroville-Thermalito Complex) releases are at 950 cfs. Exports from Clifton Court Forebay inflow are targeting 4,000–5,000 cfs. State share of San Luis Reservoir is 329 TAF.
