### • Operational Updates

- CVP: Trinity River releases are at 1,250 cfs for ongoing winter variability flows. Sacramento River (Keswick) releases are currently at 3,650 cfs. Clear Creek (Whiskeytown) releases are at 200 cfs. American River (Nimbus) releases are at 10,000 cfs. Stanislaus River (Goodwin) releases are at 1,500 cfs. Reclamation's Delta pumping is at 5 units and targeting 4,200 cfs. Federal share of San Luis Reservoir is 845 TAF (projected to fill in early April).
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 15,000 cfs. Clifton Court exports are 6,680 cfs; the maximum limit per Army Corps permit requirements. State share of San Luis Reservoir is full.
- Hydrology Update (DWR and Reclamation)
  - After today's storm, not much precipitation in the forecast until a small event next Tuesday and Wednesday.
  - Air temperatures are projected to be cooler than average for the coming week.
  - River stage at Vernalis is hovering at the flood/danger stage at least through the weekend, and is projected to remain above monitor stage for at least the next ten days.
