• Operational Updates

- CVP: Trinity River releases are at 1,100 cfs for ongoing winter variability flows. Sacramento River (Keswick) releases are currently at 3,250 cfs; likely to hold there unless see some side flows into Keswick. American River (Nimbus) releases are at 7,000 cfs. Stanislaus River (Goodwin) releases are at 300 cfs for a few days in support of monitoring needs. Reclamation's Delta pumping is at 5 units; expected to decrease to 4 units on Saturday. Federal share of San Luis Reservoir is 909 TAF (projected to fill in early April). Once the federal share of San Luis is full, pumping will depend on real-time demand.
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 15,000 cfs. Clifton Court exports are 5,500 cfs; limited only by real-time demand. State share of San Luis Reservoir is full.
- Hydrology Update (DWR and Reclamation)
 - After today and until April 4, there is a low chance of precipitation except maybe in the north. After April 4, the forecast looks dry.
 - Reclamation noted that in 1995, extended cold spring weather delayed snowmelt runoff in some basins.
