GRANT PROCESS: In 2021, the California state legislature appropriated funding to the Department of Fish and Wildlife (Department) to "develop a grant process to allocate funds to pay for the deterrence of wolf presence near livestock, the impacts of wolf presence on livestock, and for verified loss of livestock for participating ranchers." The Department has developed a Wolf-Livestock Compensation Pilot Program to support all three prongs of this legislative directive. Livestock producers operating within known wolf pack territory may apply for compensation for the use of various nonlethal deterrent tools and techniques to deter wolf presence near livestock (prong 2).
