Overview (Required) -** Summarize the proposed changes to regulations: Modify the boating regulations on the Lake Earl Wildlife Area (LEWA) to allow / indicate that during the waterfowl season "Only non-motorized boats or boats with electric motors may be used". Currently reads "motors prohibited during waterfowl season."
- 4. Rationale (Required) Describe the problem and the reason for the proposed change: The Lake Earl Wildlife Area comprises roughly 6100 acres of land, wetlands, dunes, and open water. Motorized boats are allowed outside of the waterfowl season for recreation and fishing. During the fall and winter months the open water surface area ranges from 2,500 to 3,000 acres depending on rainfall accumulation. The main body of water is Lake Earl which is roughly 1 mile wide and 3.5 miles long. Lake Earl is connected with the smaller Lake Tolowa via a narrow channel. Lake Tolowa is roughly <sup>1</sup>/<sub>4</sub> mile wide and 1 mile long. Being adjacent to the coast, Lake Earl and the Lake Tolowa are subject to significant and often severe weather conditions for most of the waterfowl season. Strong winds, rain,

and wind driven waves are frequently encountered while hunting. Additionally during most waterfowl hunting seasons the dune between Lake Tolowa and the Pacific Ocean is mechanically breached to alleviate flooding. Both of the Lakes are then also affected by tidal influence from the Pacific Ocean. All of that contributes to unnecessary and often extraordinary efforts needed to safely navigate the water surfaces with oar or paddle propulsion. Significant winds frequently limit proceeding in any direction other than downwind, which then can make a return trip potentially also very problematic. This presents a safety issue to waterfowl hunters at times. It is not uncommon for hunters to leave their boats and gear on the shoreline and walk out to the few nearby county roads or alternately stay put until the winds subside. . Out of the roughly 30 State Wildlife Areas with waterfowl hunting and concurrent boat related regulations: 21 allow boats with no motor restrictions; 3 prohibit boats; 4 allow only non-motor driven boats or boats with electric motors; and 1, the Lake Earl Wildlife Area, prohibits motors completely during the waterfowl season. Lake Earl is the "largest Estuarine Lagoon on the West Coast". The other lagoons along the California North Coast (Big Lagoon, Stone Lagoon, and Freshwater Lagoon) are smaller than Lake Earl and all allow motor boats and hunting during the waterfowl season. It is already illegal to shoot waterfowl from a watercraft that is under power, so use of an electric motor falls under that restriction. Being able to navigate the Lakes with assistance from an electric motor also provides hunting opportunity to those that may be unable to physically row the distances required to access most of the water surface and shoreline areas open to waterfowl hunting. 90% of the roughly 60 miles of shoreline around the Lakes is accessible for hunting by boat only. Additionally, there are no "reasonable accommodation" measures or means for disabled hunters on the LEWA.
