- Operational Updates
  - CVP: Trinity River releases are at 450 cfs. Sacramento River (Keswick) releases are currently at 9,500 cfs and increasing to 10,000 cfs on Saturday. Clear Creek is at 150 cfs. American River (Nimbus) releases are at 4,000 cfs. Stanislaus River (Goodwin) releases are at 1,500 cfs during the week and 750 cfs on weekends for

boater safety. Reclamation's Delta pumping is at 4 units targeting 3,500 cfs. Federal share of San Luis Reservoir is 961 TAF. Delta Cross Channel gates opened for the season on Friday 6/23 and are expected to remain open all summer and into the fall.

- SWP: Feather River (Oroville-Thermalito Complex) releases decreased to 2,100 cfs today and will further decrease to 1,900 cfs tomorrow. Clifton Court Forebay exports are at zero today and tomorrow for herbicide application; exports will start increasing on Friday 7/1. State share of San Luis Reservoir is at 1,046 TAF.
- Hydrology Update (DWR and Reclamation): There is an excessive heat warning this weekend, and weather is forecasted to be dry.
