Job Description/Summary:

Wildlife Management Program: Assist Wildlife Management staff with direct support to ongoing botulism monitoring program. Surveys conducted on land and water to assess disease events. Travel by jet boat, airboat or vehicle to locate disease hotspots. Collection and identification of sick and dying birds. Transport and rehabilitation of sick birds. Collection and submission of lab samples for disease testing. Surveying nesting bird colonies. Identification and estimation of abundance by bird species and delineation of nesting colonies. Accurately collect and record data in the field. Assist Wildlife Management staff in conducting wildlife surveys and monitoring on Department sponsored or managed projects. Assist with capture and handling of various wildlife species. Identify plants and animals to species and record data accurately in the field.

Perform routine maintenance and cleaning of Department-owned lands and equipment. Tasks include fence repair, construction, trash pick-up, cleaning of facilities, vehicle maintenance/cleaning, sign posting, and weed control. Assist with administrative tasks such as purchasing, copying, filing, and mailing.
