



# License Agent Free Hunt Days Information and FAQs

## 2024/2025 FREE HUNT DAYS

**Saturday, November 23, 2024 & Saturday, April 12, 2025**

### FREE HUNT DAYS

Hunters wishing to participate in Free Hunting Days shall only participate for one license year and shall only take resident and migratory game birds, resident small game mammals, fur-bearing mammals, nongame mammals and wild pigs with a wild pig tag.

Free Hunting Day participants are subject to all limitations, restrictions, conditions, statutes, rules and regulations, except the required possession of a valid hunting license, upland game bird hunting validation and state duck hunting validation.

### FREE HUNT DAY REQUIREMENTS (Fish and Game Code § 3040)

California residents that do not currently hold a valid hunting license and meet the requirements below may participate in the two free hunt days:

- ✓ **Proof of completion of a hunter education course**
- ✓ **Possession of a valid Free Hunt Days Registration**
- ✓ **Possession of any required tags or report cards, federal entitlements and entry permits**
- ✓ **Participants must be accompanied by a licensed hunter who:**
  - **Holds a valid California hunting license**
  - **Is at least 21 years of age**
  - **Only accompanies one free hunting day participant in the field at a time**

### FREE HUNT DAYS REGISTRATION – **AVAILABLE OCTOBER 9, 2024**

Starting October 9, 2024, customer may claim the Free Hunt Days Registration for the 2024/2025 hunting season through all sales channels (CDFW license sales offices, license agents, online sales website, and telephone sales).

## Frequently Asked Questions

### **Q: Who is eligible for the Free Hunt Days Registration?**

**A:** California residents who do not hold a current valid annual hunting license.

### **Q: How long is the Free Hunt Day Registration valid?**

**A:** The Free Hunt Days Registration is valid for two designated days each year. The 2024-25 hunting license year's free hunt days are November 23, 2024 and April 12, 2025. Free hunt days are published each year in the Hunting Regulations Booklets.

### **Q: What does a customer need to do to claim the Free Hunt Days Registration?**

**A:** The participant shall complete the following requirements to register for a Free Hunt Days Registration:

- Complete a hunter education course before registering.
- Be accompanied by a hunter who is 21 years of age or older and possesses a current valid California hunting license.
  - The licensed hunter may only accompany one unlicensed hunter in the field at a time.

### **Q: How many years can a person participate in Free Hunt Days?**

**A:** A resident may only register and participate in free hunting days for one license year.

### **Q: Where does a customer register for a Free Hunt Days Registration?**

**A:** The Free Hunt Days Registration is available anywhere CDFW licenses are sold. At CDFW license sales offices, license agents, and through our online sales website and telephone sales services.

### **Q: What can a customer hunt for with a Free Hunt Days Registration?**

**A:** The Free Hunt Days Registration allows participants to take only resident and migratory game birds, resident small game mammals, fur-bearing mammals, nongame mammals and wild pigs.

A participant with a Free Hunt Days Registration must also be in possession of any required tags, report cards, entry permits or required federal entitlements, and must follow restrictions, conditions, statutes, rules and regulations applicable to anyone holding a valid hunting license.



# License Agent Free Hunt Days Information and FAQs

**Q: Can a customer hunt wild pig on Free Hunt Days?**

**A:** Participants wishing to hunt wild pig on Free Hunt Days are required to purchase a "Wild Pig Tag - Free Hunt Days" when claiming their Free Hunt Days Registration. To hunt wild pigs, participants must be 12 years of age or older.

**Q: Can a customer apply for drawings with a Free Hunt Days Registration?**

**A:** No. A Free Hunt Days participant is an unlicensed hunter and shall not apply for any draw or lottery to obtain any tag, reservation, or other hunting opportunity.

**Q: Can a customer use a hunting license from another state to participate in Free Hunt Days?**

**A:** No, a hunting license from another state cannot be used to participate in Free Hunt Days.

**Q: Does a customer need a hunter education certificate?**

**A:** Yes. Free Hunt Days participants must complete and provide a hunter education certificate to claim their Free Hunt Days Registration. CDFW accepts hunter education certificates from any state. Hunter education classes are available in two formats. Customers can view California hunter education options at [wildlife.ca.gov/Hunter-Education](http://wildlife.ca.gov/Hunter-Education).

**Q: Can a customer use a Free Hunt Days Registration to hunt on state-managed wildlife areas?**

**A:** On the Free Hunt Days, participants may hunt on state-managed wildlife areas but will need to purchase a wildlife area pass. Customers may find more information about passes for state-operated hunting areas at [wildlife.ca.gov/licensing/hunting](http://wildlife.ca.gov/licensing/hunting).

# License Agent Free Hunt Days Registration Internet Point of Sale (IPOS) Terminal Instructions

1. Retrieve the customer record for the individual participating in the Free Hunt Days.
2. Select the appropriate year's **Hunting** tab, then select **Add** on the **Free Hunt Days Registration** item.

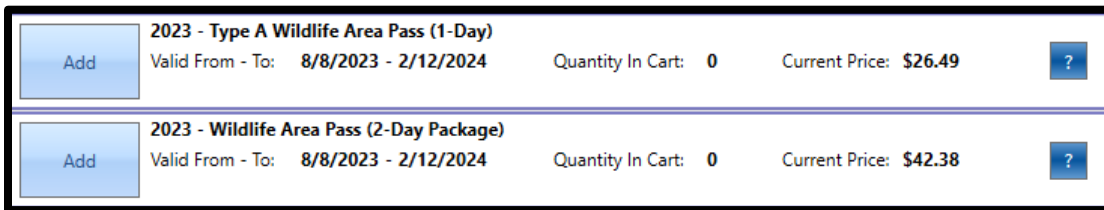


# License Agent Free Hunt Days Registration Internet Point of Sale (IPOS) Terminal Instructions

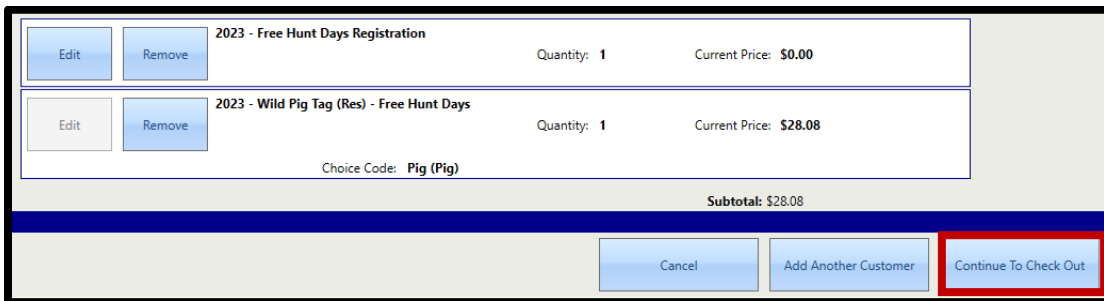
- After all desired items are added to the cart, select **Go To Cart**.

- Verify all documents in the cart are correct and select **Continue To Check Out**.



- Complete the Transaction. Collect any funds due and provide the printed documents to the customer.
